All communications relating to Trade marks should be addressed to the Registrar of Trade marks, Department of the Registrar of Companies, Block 5, Echelon Square, Colombo 1.

Hours of Inspection

The office shall be open to the public every week day except Saturday, between the hours of ten to four, and on Saturdays between the hours of ten to one, except on public holidays. Applications for inspections will, however, be accepted up to 3 p.m. on week days and 12 noon on Saturdays.

Trade Marks limited to Colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colours the colours are, so far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner.

Association

Where it is stated that an advertised mark is to be associated (under Section 22 of the Trade Marks Ordinance (Cap. 131)) with another mark, it is indicated by its official number.

Applications in Part A or Part B

Applications for registration in Part A of the Register are shown with the official number unaccompanied by any letter. Applications for Part B of the Register are distinguished by the letter B prefixed to the official numbers.

OPPOSITION

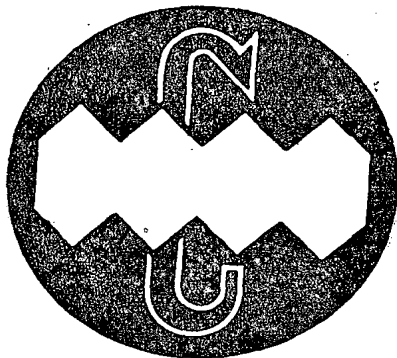
NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge Notices of Opposition on form T. Abstract.—The nature of the invention can be ascertained from claim 1 which reads as follows:—

1. A cyclopropanecarboxylic acid esters having the general formula.—



where in X¹, X², X³, and X⁴ each means a member selected from the group consisting of hydrogen and halogen atoms, and methyl and acetoxy radicals; Z is a member of oxygen and sulfur atoms; F means a double bond at any position of the cyclohexane nucleus, and R is a member selected from methyl and methoxycarbonyl radicals.

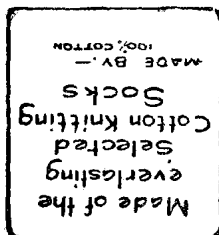
