##### Trade Marks limited to Colours

“Sulfapyrimidines and process for the manufacture thereof”.

*Abstract.*—A process for the manufacture of substituted pyrimidines of the general formula III wherein Ac represents an acyl residue is described.

A compound of the general formula I wherein R represents a group convertible into an amino group by reduction or hydrolysis is reacted with an acylating agent to form N'-acylated compound of the general formula II which are then reduced or hydrolysed to form compounds of the general formula III.



A process for the manufacture of pharmaceutical preparations containing these compounds is described.

There are 13 claims and 3 examples.
