Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant for registration as to afford him an opportunity of withdrawing his application before the expense of preparing the Notice of Opposition is incurred. Failure to give such notice will be taken into account in considering any application by an Opponent for an Order of Costs if the opposition is uncontested by the Applicant.

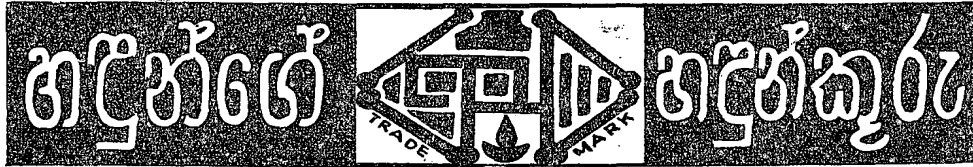

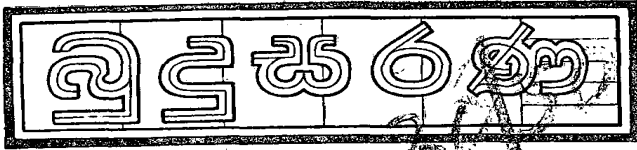

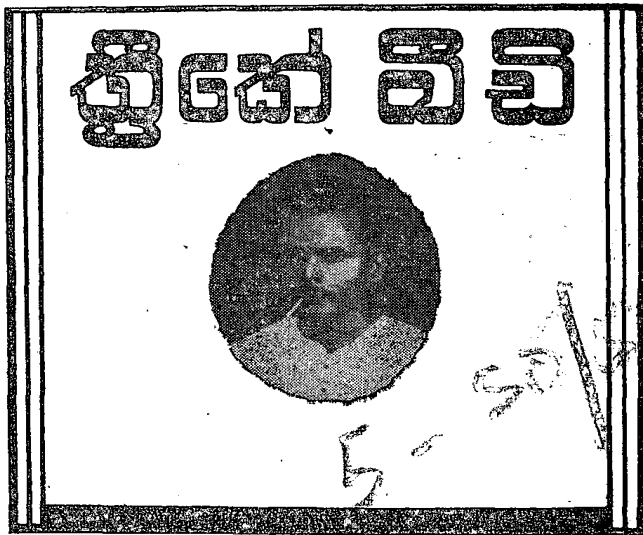
