NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 19th day of August, 1899, the persons, if any, who claim any interest in the lands hereinafter mentioned, or in any one or more of such lands, appear before me at my office at Matara and make claim to the said lands or any of them, or to some interest therein :

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand that the said lands, or such of them to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

I.

The land commonly called or known as Neluketiyehena, Gangabodahena, Welilindahena, Radaliyawehelena, Elabodahena, Tennandayayehena, Wattehena, Dolehena, and Denukittehena, all lying adjacent to each other and forming one block, situate in the village of Kiripitiya in the Morawak korale of the Matara District, in the Southern Province, containing in extent 560 acres and 2 roods, as described in the annexed plan, shown as lots 2 and 270 in sheets O 10 51, 52, 59, 60, O 10 53, 54, 61, 62', O 15 3, 4, 11, 12' and O 15 5, 6, 13, 14'; and bounded as follows: on the north by the Hankohu-ela or Moragala-ganga, Penikoladeniya belonging to Pitawitige Kiri Appu and others, the Penikolahenedola, the old footpath from Beralapanatara to Urubokka dam, Beruliewie-mukalana belonging to Crown, the Urubokke-ganga, Kariwilehena belonging to Crown; on the east by the minor road from Beralapanatara to Urubokka, Ratambaladeniya belonging to D. N. Abewickrama and others, the minor road from Beralapanatara to Urubokka, the Gansabhawa path from Kirilapane to Urubokka; on the south by the Gansabhawa path from Kirilapane to Urubokka, and Godamagewatta belonging to Diyapotage Luwis Hami and others; on the west by the Galkaduwedola (stream), Diwelkanekumburuyaya belonging to Welappulige Ukku and others, Ganelyyamulla belonging to Gamage Andris and others, Egodawatta belonging to Gamage Wattuhami and others, Dolewatta belonging to ditto, Kandedeniyedola, Horakandagawadeniya belonging to ditto, Dolehena belonging to Crown, Batehena belonging to Crown, Kosgulanehena belonging to Crown, the Wattehenedola (stream), Kudagalalahena belonging to Crown, Witibudeniyew mukalana belonging to Crown, the Urubokke-ganga, excluding Wattadeniya in extent 1 acre 1 rood and 12 perches marked A in the annexed plan and belonging to D. F. de Silva Abewardana, Kandedeniya in extent 1 acre and 2 perches marked B and belonging to Gamage Thomis, and Kandedeniya in extent 1 rood marked C and belonging to ditto, which are included within these boundaries.

II.

The land commonly called or known as Alutgeimehena, Radaliyawehelena, Paranapettanhena, and Imehena, all lying adjacent to each other and forming one block, situate in the village of Kiripitiya in the Morawak korale of the Matara District, in the Southern Province, containing in extent 61 acres and 10 perches, as described in the annexed plan, shown as lots 9 and 18 in sheet O 15 5, 6, 13, 14' and bounded as follows: on the north by Kiripitiyawela belonging to Gamage Babe Hami and others, Pallehawatta belonging to Manamperige Don Andris and others, Bemmwewatta belonging to Diyapotage Luwis Hami and others, Kiripitiyawela belonging to Gamage Babe Hami and others, Millemullewatta belonging to Diyapotage Siman and others; on the east by the minor road from Beralapanatara to Urubokka, Liyangahahena belonging to Crown; on the south by Karaelwila belonging to Diyapotage Luwis Hami and others; on the west by Kanamiyagalahena claimed by Diyapotage Janis, Kunukosgahahena claimed by ditto, Godakumburawatta belonging to D. N. Abewickrama and others, Halpilledeniya belonging to Diyapotage Luwis Hami and others, Kiripitiyawela belonging to Gamage Babe Hami and others.

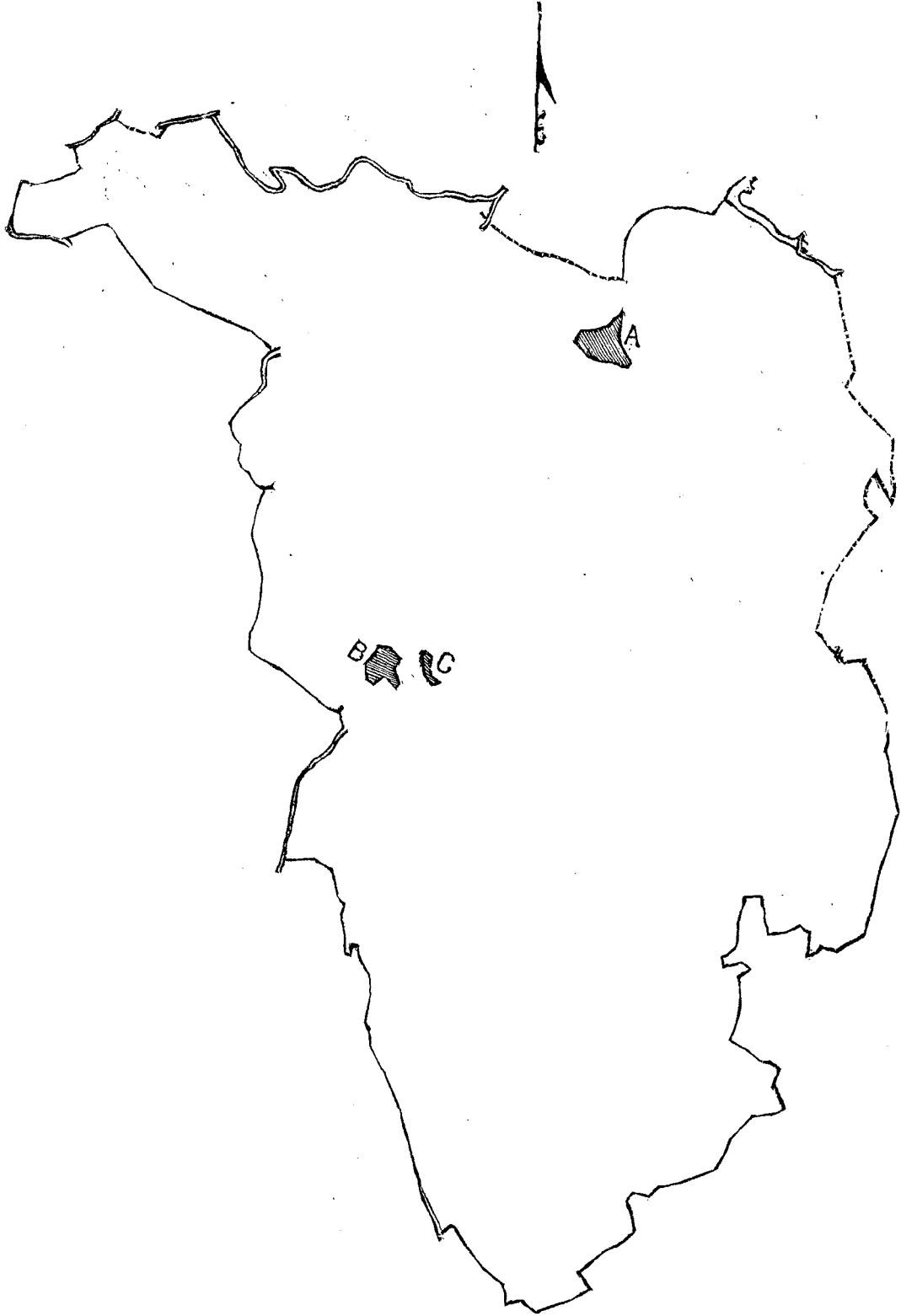

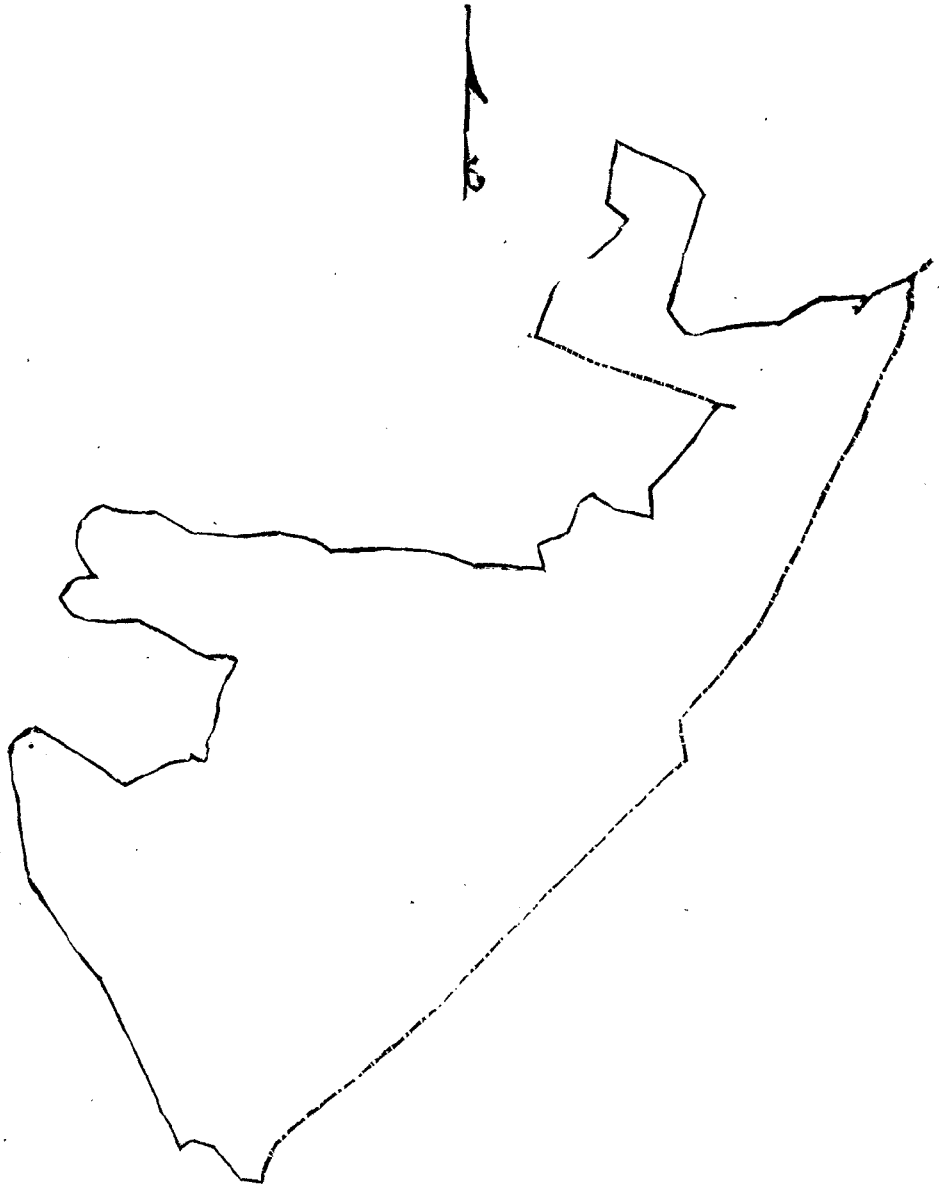
