The Rules rate under the Council of Leval Education Incorporation Ordinance, as last amended by notification dated October 5, 1964, published in the Ceylon Government Gazette No. 14,211 of October 30, 1964, were further amended at a meeting of the Council of Legal Education held on July 30, 1965, as follows:—

- (a) Rule 23 (1) A, by the addition of the words "or has passed the B.A. (General) Degree Examination in Public and Business Administration of the Vidyodaya University of Ceylon" after the word "Rule" in line 3.
- (b) Rule 23 (1) B (i), by the addition of the words "or the Intermediate Examination in Public and Business Administration of the Vidyodaya University of Ceylon" between the word "London" and the word "or" in line 2.
