This scheme for leasing land is intended primarily for large scale development and as a general rule applications will be considered for extents over 100 acres where permanent crops are to be established or animal husbandry is to be undertaken, and for extents over 25 acres where annual crops are to be established.

6. Applications should be made on the special printed forms available from the Secretary, Special Leases Board, Ministry of Land, Irrigation and Power, and from the Government Agents of the Districts mentioned in paragraph 1 above.

7. Land under the scheme will be leased for a period up to 25 years with the option on the part of the Government to renew the lease for a further period or resume the land on payment of appropriate compensation.

8. Certain tax concessions for land development and food production under this scheme will be made available as provided for in the Inland Revenue Act and the proposed amendments thereto.

9. Applicants should make a refundable deposit of Rs. 250 in favour of the Government Agent of the administrative district in which the land applied for is situated, and he should forward the receipt together with the application. If alternative blocks of land are applied for, separate applications should be made in respect of each block of land and separate deposits should be made in respect of each application.

10. Applications should be made in sextuplicate and should reach the Secretary, Special Leases Board, Ministry of Land, Irrigation and Power, The Secretariat, Galle Face, Colombo 1, by the 15th October, 1965, in respect of the lands to be cleared in 1966.
