NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 1st day of September, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at my office at Matara and make claim to the said land or to some interest therein :

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

The land commonly called or known as Priyamalahena alias Kiriwandolahena, Mandolahena, Haldolahena, Galabendi-hena, Kolamitiyadolahena, Haldolahenamukalana, Galabendihenamukalana, Molehena, Uda-arambehena, Maussawehena, Nayinduwemukalana, and Pahalawattehena, all lying adjacent to each other and forming one block, situate in the village of Uduwaka Matugobe in the Morawak korale of the Matara District, in the Southern Province, containing in extent 375 acres and 39 perches, as described in the annexed plan, shown as lots 1, 2, 3, 5, 6, 8, 15, 16, 19, 29, 40, and 60 in sheets Nos. O 10/34.42, O 10/35.43, and O 10/51.59, and bounded as follows : on the north by Kekunahena sold by Crown to E. L. Issan Appu and others, (title plan 145,265), Kukulwilawatta sold by Crown to Mr. D. Church (title plan 111,409), Aninkanda estate (title plan 101,410) ; on the east by Dotalugalahena belonging to Crown, the Kalawitiyadola (stream) ; on the south by the Kalawitiyadola, Inalagalalandemillahena belonging to Crown, Kiwlemukalana belonging to Crown ; on the west by Wamporagahahena belonging to Crown, Olekandewatta sold by Crown to Wattuhami Mudalali (title plans 165,134 and 166,814), the Maussawehenedola, Kiriwanedola, Matillawatta claimed by Ranamukage Loku Appu, the Gansabhawa road from Deniyaya to Beralanatara, and Iriyamalahena claimed by Subehami.

[NOTE.—The following lots lying within the above-named boundaries are excluded from this notice, and their aggregate acreage, viz., 50 acres 3 roods 9 perches, is not included in the acreage of 375 acres 0 roods 39 perches above-named :—

(3) Pahalawatta and Pahaladeniya, forming block marked C in the annexed plan, and shown as lots 31 and 32 in sheets Nos. O 10/34.42, O 10/35.43, and O 10/51.59, in extent 3 acres 1 rood and 21 perches.

(4) Hembapedigewatta alias Potdanagewatta, marked D in the annexed plan, and shown as lot 30 in sheets Nos. O 10/34.42, O 10/35.43, and O 10/51.59, in extent 8 acres 2 roods and 8 perches.]

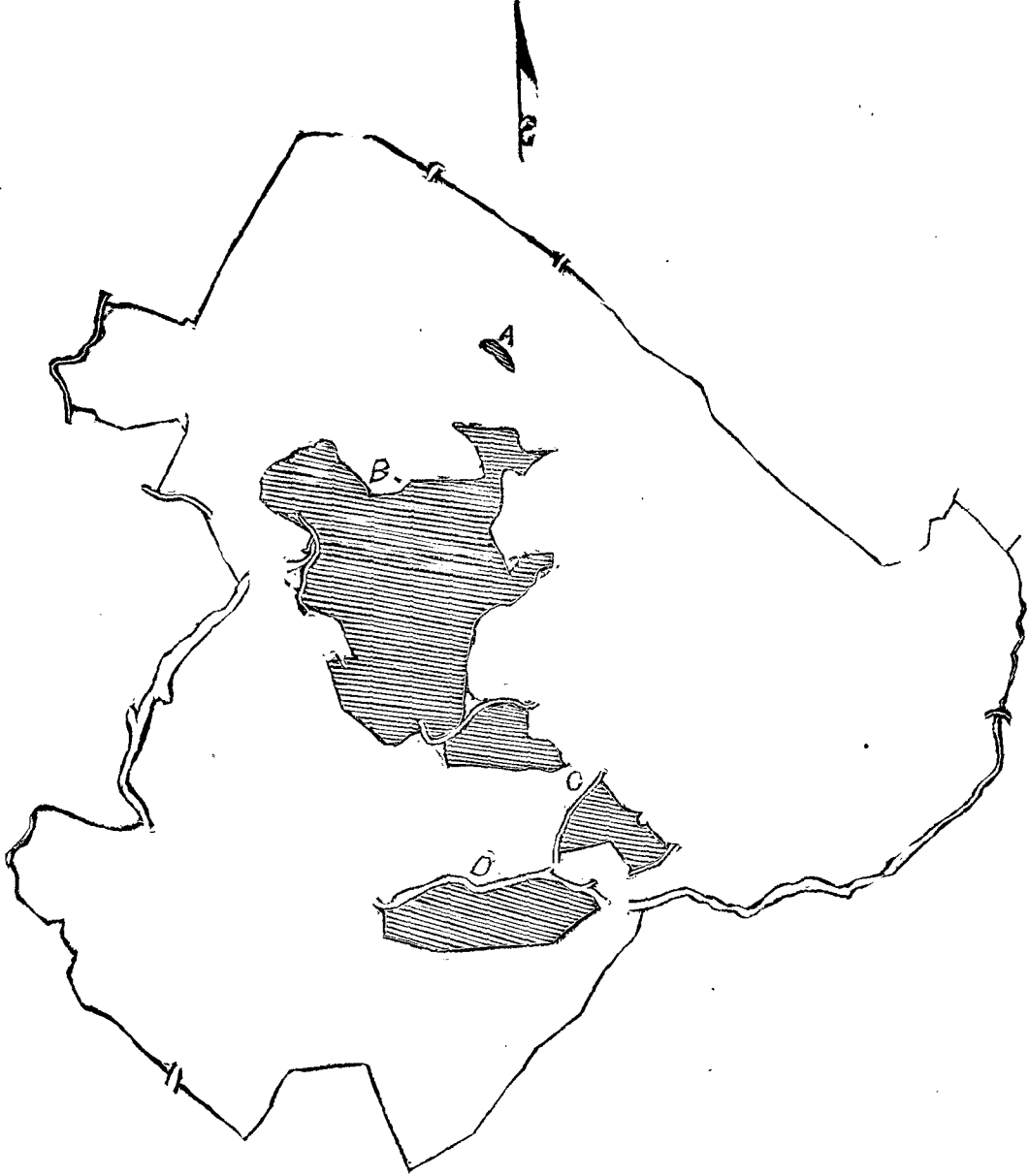
