#### ORDER

Vesting Order No. 1849 of August 31, 1962, relating to Ch/Wennappuwa (Roman Catholic) Boys' School, Wennappuwa, published in Ceylon Government Gazette (Extraordinary) No. 13,296 of September 8, 1962, is hereby smended in the Schedule thereto, by the substitution for paragraph 1 thereof of the following paragraph:—

"1. (a) The premises in which Ch/Wennappuwa (Roman Catholic) Boys' School, was conducted and maintained on July 21, 1960, viz., all that portion of land called and known as Wennappuwa R. C. Boys' School premises, situated in Ulhiti-

yawa of Pitigal Korale South, in the District of Puttalam, North-Western Province, and which portion is bounded on the—

West by the V. C. Road running southwards from the old Post Office Road;

North by a line starting at a point on the western boundary 169 feet south of the said old Post Office Road. It runs to a distance of 118 feet due east and turning at right angles runs northwards to a distance of 80 feet, then turning at right angles runs to a distance of 213 feet due east and then turns at right angles and runs northwards till it meets the said old Post Office Road and running eastwards along this old Post Office Road to a distance of 232 feet, and turns south at right angles and runs to a distance of 93 feet and again turns eastwards at right angles and runs till it meets the Colombo-Puttalam Road;

East by Colombo-Puttalam Road;

South by a line starting on a point on the eastern boundary 114 feet south of the eastern extremity of the aforesaid northern boundary and runs westwards to a distance of 274 feet, then turns northwards at right angles and runs for 13 feet, then it turns westwards at right angles and runs to a distance of 235 feet and turns southwards at right angles and runs to a distance of 81 feet, then it turns westwards at right angles and runs to a distance of 81 feet, then it turns westwards at right angles and runs till it meets the aforesaid V. C. Road.

(b) The full and free right and liberty at all times to use the existing road access to the school premises, the water carriage system and the lighting installations ".
