IMPORT CONTROL NOTICE 7/66

AT present the debit on partial shipments made on Actual User licences issued by this Department is done at the "Customs Unit" situated at the new Y.M.B.A. Building Fort.

2. Importers on Actual User licences are hereby informed that with effect from 15th March, 1966, all partial debits of Actual User licences will be done at the Import Control Unit at the Ministry of Industries and Fisheries, 46, Sri Jinaratana Road, Colombo 2.

3. All Actual User importers should, therefore, with effect from this date hand over their documents for debiting in respect of their partial shipments at the Import Control Unit, Ministry of Industries and Fisheries.

4. There will be no change in regard to the present arrangement whereby final debits on Actual User licences are made at the Import Control Unit, Ministry of Industries and Fisheries.
