Order

The provisions of paragraphs (1), (2) and (3) of the notification relating to the Alankerny and Kurinchakerny village areas in the

Trincomalee District, made under section 8 of the Village Councils Ordinance (Chapter 257) and published in this Gazette shall—

(i) in so far as those provisions relate to any matter connected with the general election of the members of the Village Council of each of the aforesaid village areas to be held in the year 1966, come into effect on the date of the publication of this Order in the Gazette; and

(ii) in so far as those provisions relate to any other matter come into effect on February 1, 1966.

THE VILLAGE COUNCILS ORDINANCE

Notification

BY virtue of the powers vested in me by section 8 of the Village Councils Ordinance (Chapter 257), as amended by Act No. 60 of 1961, I, Murugeysen Tiruchelvam, Minister of Local Government, do hereby—

- (1) subdivide the existing wards in the Alankerny village area in the Trincomalee District into wards with the limits specified in the First Schedule hereto;
- (2) subdivide the existing wards in the Kurunchakerny village area in the Trincomalee District into wards with the limits specified in the Second Schedule hereto;
- (3) rescind the Notification relating to the sub-division of the Grama Sevaka Divisions in certain village areas in the Trincomalee District into wards, published in Gazette No. 8,597 of March 29, 1940, in the Schedule thereto, in so far as it relates to the Kinniya village area; and
- (4) declare that the provisions of paragraphs (1), (2) and (3) shall—

- (a) in so far as these provisions relate to any matter connected with the general election of the members of the Village Council of each of the aforesaid village areas to be held in the year 1966, come into effect on the date on which this Order is published in the Gazette; and
- (b) in so far as these provisions relate to any other matter, come into effect on February 1, 1966.

THE VILLAGE COUNCILS ORDINANCE

Order

BY virtue of the powers vested in me by sections 5 and 10 of the Village Councils Ordinance (Chapter 257), as amended by Act No. 60 of 1961, I, Murugeysen Tiruchelvam, Minister of Local Government, do by this Order—

- (1) divide the village area of Kinniya in the Trincomalee District into the new two village areas of Alankerney and Kurunchakerny comprising such of the Grama Sevaka Divisions as are more fully described in the First and Second Schedules hereto respectively; and
- (2) appoint the first day of February, 1966, as the day on which the term of office of the Village Councils to be constituted for each of the aforesaid village areas shall commence.
