NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 21st day of August, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Ratnapura Kachcheri and make claim to the said land or to some interest therein :

I, Leonard William Booth, Government Agent for the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinance No. 1 of 1897, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

Land lot No. A, described in the annexed plan of survey No. ⁸_{P. S.}, called Hedillehena, situate at Ekneligoda in the Uda patta wa of the Kurnwiti korale in the District of Ratnapura, in the Province of Sabaragamuwa, containing in extent 9 acres 1 rood and 34 perches; and bounded on the north by Mapitikele claimed by the heirs of the late J. W. L. Elapata and others; on the east by Gangabodawatta claimed by Pinkhami and others, Baddiyawatta claimed by Ekneligoda Dissawa, Kajugahawatta claimed by Ranna Sinna and others; on the south by garden claimed by Marukge Punchilamaya called Hedillehenawatta and Crown land called Delgomuwakele; and on the west by Crown land called Delgomuwakele.


