The provisions of paragraphs (1) and (2) of the Notifications relating to the village areas of Wellawa and Maspotha in the Kurunegala District made under section 8 of the Village Councils Ordinance (Chapter 257), and published in this *Gazette*, Shall—

(1) in so far as those provisions relate to any matter connected with the general election of members of the Village Councils of the aforesaid village areas to be held before the first day of February, 1966, come into effect on the date on which this Order is published in the *Gazette*; and

(2) in so far as those provisions relate to any other matter come into effect on the first day of February, 1966.
