#### GOVERNMENT NOTIFICATIONS.

HE following amended regulations made by the Governor, with the advice and consent of the Executive Council, in pursuance of the powers vested in them by sections 18 and 21 of "The Cemeteries Ordinance, 1862," in respect of the general cemetery known as the "Liveramentu" Cemetery situated in the village Narahenpita in Palle pattu of Salpiti korale, in the District of Colombo, Western Province, are hereby published for general information, and the existing regulations, dated March 6, 1897, and published in the Government Gazette No. 5,464 dated March 12, 1897, are hereby cancelled and withdrawn,

Rules made under the provisions of Ordinance No. 12, of 1862.

1. All applications for graves are to be made to the keeper of the cemetery at least

six hours before the time fixed for the burial of the body for which the grave is required.

2. The keeper must intimate the line to be followed by a funeral party on arriving at the cemetery, and, if more than one come at the same time, the order in which they are respectively to move to the graves.

3. Should it be necessary, for the purpose of preventing the disturbance of one funeral party by the other, and not otherwise, the keeper of the cemetery may require that one burial service should be concluded before another can be commenced.

4. The keeper of the cemetery shall be entitled to keep order within the cemetery,

and his commands are to be obeyed.

5. No grave shall be less than 4 ft. in depth or at a distance of less than 4 ft. from any other. No grave shall be re-opened within a year, nor vault within six months, from the date of the last interment therein, except upon orders from a competent Police Magistrate.

6. The keeper of the cemetery shall send weekly to the Registrar-General a copy or transcript of the register of burials in respect of burials from within the Municipal

7. The keeper of the cemetery shall not permit the interment of the dead body of a person resident within the Municipal limits of Colombo, except upon the production of a certificate signed by a Registrar of Deaths appointed under the provisions of the Ordinance No. 1 of 1895, or on production of a certificate in due form from an officer in charge of a police station or a vidane arachchi, or on production of a certificate in due form as to the cause of death from the medical practitioner attending on the deceased, or on production of an order from an Inquirer into Deaths.

A "medical practitioner" is a person holding any English medical degree or who is a Licentiate of the Ceylon Medical College.

8. No dead body shall be buried without the permission of the cemetery-keeper; such permission shall not be granted till all fees due have been paid.

9. The following fees shall be paid in advance:—

For building a vault 1 ft. shall be allowed for each side wall, and the space of ground above specified shall on no account be exceeded, nor shall any allowance be made for the construction of steps leading into the vault.

10. On the production of a certificate signed either by a minister of the Christian

religion or by the Mudaliyar of the district or a Justice of the Peace or a member of the Municipal Council that the relatives and friends of any deceased person are not able to pay the fees herein prescribed for the digging of a grave, the keeper of the cemetery shall cause a grave to be dug and the corpse to be buried therein free of charge.

Parties may choose the person to perform the burial service, and the fee agreed

upon shall be paid to him by the parties concerned.

WHEREAS by section 6 of "The Cemeteries Ordinance, 1862," it is enacted that whenever a cemetery, under the provisions of section 5 of the said Ordinance, is established in any place the Governor may, with the advice and consent of the Executive Council, order that, after a time to be mentioned in the order, burials in all or certain of the burial grounds within such place and limits shall be wholly or partially discontinued:

And whereas by a Proclamation dated the 6th day of August, 1885, a general cemetery was, under the provisions of section 5 of the said Ordinance, established for the town of Anuradhapura,

North-Central Province, within the limits specified and defined in the said Proclamation:

It is hereby notified that the Governor, with the advice and consent of the Executive Council, has, by virtue of the powers conferred upon him by section 6 of the said Ordinance, ordered that from and after the 1st day of March, 1898, all burials in the burial ground known as the Roman Catholic burial ground in the town of Anuradhapura, specified and defined in the schedule hereto, shall be wholly discontinued.

THE following extract from a despatch dated 18th December, 1897, from the Secretary of State for the Colonies, is published for the information and guidance of the officers concerned:—

"Letters recommending Colonial Officers for promotion or honours are received at this office from so many correspondents, who appear to have been appealed to on the ground of their supposed influence, but who have neither themselves been connected with the Colonial Service nor are in a position to judge of the merits of other candidates for similar promotion, that I am compelled to request you to make it known among such officers of your Government as it may be likely to affect, that I do not approve of the use of these means to influence my judgment, and that applications of this kind are by no means necessarily of advantage to the persons recommended in obtaining the fulfilment of their wishes.

"I do not mean to suggest, however, that the great majority of Colonial Officers have not already a perception of the drawbacks and the irregularity of the proceedings upon which I have felt it my duty to comment, and this should be stated in the communication which I have directed you to

make to your officers on the subject.

"It should also be stated that I have no wish to discourage direct applications from officers who desire promotion to particular appointments, or who consider that their services entitle them to promotion generally. Such applications will continue to receive my careful consideration, provided, of course, that, if the officer is in the colony when he applies, the Colonial Regulations as to the transmission of correspondence through the Governor are complied with.

"If an officer applies while on leave of absence in this country, the application will, when there is any occasion to do so, be referred to the Governor, unless there is a recent report respecting

him on record in this office."

#### No. XIII.

An Act to place certain restrictions on Immigration.

Assented to December 23, 1897.

Preamble.

WHEREAS it is desirable to place certain restrictions on immigration: Be it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of Western Australia, in this present Parliament assembled, and by the authority of the same, as follows:

Short title.

This Act may be cited as "The Immigration Restriction Act, 1897."
 This Act shall not apply to—

Exemptions.

- (a) Any person possessed of a certificate in the form set out in the schedule to this Act and signed by the Colonial Secretary or the Agent-General of Western Australia, or any officer appointed by the Governor for the purposes of this Act, whether in or out of Western Australia;
- (b) Any person of a class for whose immigration into Western Australia provision has been made by law, or by a scheme approved by the Governor;
- (c) Any person specially exempted from the operation of this Act by a writing under the hand of the Colonial Secretary or any officer appointed in that behalf by the Governor;
- (d) Her Majesty's land and sea forces;
- (e) The officers and crew of any ship of war of any Government;
- (f) Any person duly accredited to the Government of Western Australia by or under the authority of the Imperial or any other Government;
- (g) Any person landed in Western Australia under the Imported Labour Registry Act for the time being in force, or any Act amending the same;
- (h) Persons returning to the colony under certificates granted under former Acts authorizing such return.

Prohibited immigrants.

- 3. The immigration into Western Australia by land or sea of any person of any of the classes defined in the following sub-sections of this section, hereinafter called "prohibited immigrant," is prohibited, namely:
  - (a) Any person who, on being asked to do so by an officer appointed under this Act, shall fail to himself write out, in the presence of such officer, in the characters of any language of Europe, a passage in English of fifty words in length taken by such officer from a British author and to append his name thereto in his own language;
  - (b) Any person being a pauper or likely to become a public charge:
  - (c) Any idiot or insane person;
  - (d) Any person suffering from a loathsome or dangerous contagious disease;
  - (e) Any person who has within three years been convicted of a felony or infamous crime, or a misdemeanour involving moral turpitude, and not being a mere political offence, and has not received a pardon therefor; and
  - (f) Any prostitute and any person living on the prostitution of others.

Unlawful entry of prohibited immigrants.

4. Every prohibited immigrant making his way into or being found within Western Australia, in disregard of this Act, shall be deemed to have contravened this Act, and shall be liable, in addition to any other penalty, to be removed from the Colony, and upon conviction may be sentenced to imprisonment for ont more than six months without hard labour: Provided that such imprisonment shall cease for the purpose of the offender being conveyed out of the colony, or if he shall find two approved sureties each in the sum of fifty pounds for his leaving the colony within one month.

Entry permitted on certain conditions.

- 5. Any person appearing to be a prohibited immigrant within the meaning of the 3rd section of this Act, and not coming within the meaning of sub-sections (c), (d), (e), or (f) thereof, shall be allowed to be in Western Australia upon the following conditions:
  - (a) He shall, at landing in or entering the colony, deposit with an officer appointed under this Act the sum of one hundred pounds;
  - (b) If such person shall, within fourteen daysafter entering the colony, obtain from the Colonial Secretary, or person appointed under this Act, a certificate that he does not come within the prohibition of this Act, the deposit of one hundred pounds shall be returned;
  - (c) If such person shall fail to obtain such certificate within fourteen days, the deposit of one hundred pounds may be forfeited, and he may be treated as a prohibited immigrant:

Provided that, in the case of a person entering the colony under this section, no penalty shall attach to any vessel, or the owners of any vessel, in which he shall have arrived at any port of the colony.

- 6. Every person who shall satisfy the Colonial Secretary, or an officer appointed under this Act, that he does not come within the meaning of any of the sub-sections (c), (d), (e), or (f) of the 3rd section of this Act, and—
  - (a) That he is and for the preceding two years has been the registered owner of an estate in fee simple in real estate of the value of three hundred pounds in Western Australia; or
  - (b) That he is or has formerly been domiciled in Western Australia, and possesses a certificate of the Colonial Secretary or an officer appointed under this Act, under which he is then authorized to return to the Colony;

shall not be deemed a prohibited immigrant.

- 7. The wife and every minor child of any person not being a prohibited immigrant, or forbidden to enter the colony, shall be free from any prohibition imposed by this Act.
- 8. The master and owners of any vessel from which any prohibited immigrant is landed shall be jointly and severally liable to a penality of not less than one hundred pounds and not more than five hundred pounds for each prohibited immigrant so landed.

The vessel may be arrested and sold by order of the Supreme Court in satisfaction of any such penalty, or may be refused a clearance outward until such penalty has been paid and until provision has been made by the master or owners to the satisfaction of an officer appointed under this Act for the conveyance out of the colony of each prohibited immigrant who has been so landed.

- 9. A prohibited immigrant, unless allowed to enter the colony under the 5th section of this Act, shall not be entitled to a license to carry on any trade or calling, nor be entitled to acquire a lease or any beneficial interest in land, or to vote at any Parliamentary or municipal election or to be inscribed on any roll of the persons so entitled; and any license, lease, beneficial interest, or franchise granted or acquired in contravention of this section shall be void.
- 10. An officer thereto authorized by the Governor may make a contract with the master, owners, or agent of any vessel for the conveyance of any prohibited immigrant found in Western Australia to a port in or near to such immigrant's country of birth, or in or near to the place from which he set out for Western Australia; and every such immigrant, with his personal effects, may be placed by a police officer on board such vessel, and shall, in such case, if destitute, be supplied with a sufficient sum of money to enable him to live for one month according to his circumstances in life after disembarking from such vessel.
- 11. Every person who in any way wilfully assists any prohibited immigrant to contravene the provisions of this Act shall be deemed to have contravened this Act.
- 12. Every person who wilfully assists the entry into Western Australia of any prohibited immigrant of the class described in sub-section (f) of the 3rd section of this Act shall be deemed to have contravened this Act, and shall, upon conviction, be liable to be imprisoned with hard labour for any period not exceeding twelve months; but shall not be charged under this and under the last preceding section with the same offence.
- 13. Every person who shall be wilfully instrumental in bringing into Western Australia any idiot or insane person, not being domiciled or a member of a family demiciled there, without an authority signed by the Colonial Secretary, shall be deemed to have contravened this Act, and in addition to any other penalty shall be liable for the cost of the maintenance of such idiot or insane person while in the colony.

Persons possessed of property in Western Australia, or domiciled or lately domiciled there.

Wives and children of persons not prohibited from entering . Western Australia.

Liability of master and owners of ship for illegal landing of immigrants.

Disabilities of prohibited immigrants who are not allowed to enter.

Contractfor carrying away prohibited immigrants.

Offence of aiding persons to contravene the Act.

Offence of aiding persons described in a, 3 (f) to enter the colony.

Bringing idiots or insane persons into the colony.

Powers of police and others to prevent entry in contravention of the Act.

Appointment of officers for carrying out the Act.

Regulations.

- 14. Every member of the police force, and every person appointed therefor under this Act, may, subject to the provisions of the 5th section of this Act, prevent any prohibited immigrant from entering Western Australia by land or sea.
- 15. The Governor may from time to time appoint, and from time to time suspend and remove officers for carrying out the provisions of this Act, and may prescribe the duties of such officers; and such officers shall carry out the instructions from time to time given by the Minister administering this Act.
- 16. The Governor may from time to time make, repeal, and alter regulations for carrying this Act into effect, and, in relation to persons brought into Western Australia for employment in the pearl shell fishery, regulating—

The registration of such persons;

Their employment;

Their landing and the length of time and the conditions under which they may remain on shore; and generally

For preventing their entering on any portion of the colony beyond the limits in this Act mentioned in that behalf;

and such regulations shall be published in the Government Gazette, and shall be laid before the Parliament within fourteen days after such publication, if the Parliament is then sitting, and if the Parliament is not then sitting within fourteen days of its next meeting, and when so published shall have the force of law, and shall continue in force unless repealed or altered as aforesaid, or disallowed by both Houses of Parliament.

Penalties.

Jurisdiction of magistrates.

- 17. Where no higher penalty is expressly imposed, a person convicted of any contravention of this Act shall be subject to a fine not exceeding fifty pounds, and to be imprisoned, with or without hard labour, until such fine is paid or in addition to such fine, but not in any case for a period exceeding three months.
- 18. Two justices of the peace in petty sessions or a resident or police magistrate may adjudicate on all offences under this Act, except in cases involving pecuniary penalties exceeding one hundred pounds.
- 19. Nothing in this Act contained shall affect the provisions of the Imported Labour Registry Act, 1884, or any future Act regulating the registration of imported labour; or

(Save so far as regulations under this Act extend) any person brought into Western Australia for employment in the pearl shell fishery, and kept employed under contract in such fishery, or in temporary employment on shore and only on that part of the coast of Western Australia situate to the northward of the twenty-seventh parallel of south latitude, and according and subject to the regulations made under this Act.

20. Sub-section 5 of section 5 of the Chinese Immigration Restriction Act, 1889, is hereby repealed.

Imhigration Restriction Act, 1897.

(61 Vict., No. 13.)

Instructions to Officer's appointed to carry out the provisions of the Act.

1. A copy of the statute is an nexed to these instructions, and officers are required to make themselves acquainted with its provisions.

- 2. Officers are empowered to board vessels in the waters of the colony by virtue of section 40 of the Police Act, 1892, which is as follows:
  - 40. Any inspector, sub-inspector, or any non-commissioned officer of the police force or senior constable in charge of a police station shall, by virtue of his office, be an officer of Customs within the meaning of the law relating to the Customs for the time being, and shall have power, by virtue of his office, to enter at all times, with such constables as he shall think necessary, as well by night as by day, into or upon every ship, boat, or other vessel (not being then actually employed in Her Majesty's service, and not being a vessel of war, the commanding officer whereof shall hold a commission from any foreign Government or Power) lying or being in any of the waters of the said colony, or any dock thereto adjacent, and into every part of such vessel, for the purpose of searching and inspecting the same, and of inspecting and observing the conduct of all persons who shall be employed on board any such ship or vessel in or about the lading or unlading thereof, as the case may be, and for the purpose of taking all such measures as may be necessary for providing against fire and other accidents, and for preserving peace and good order on board of any such ship or vessel, and for the effectual prevention or detection of any felonies or misdemeanours.

3. Officers stationed at the ports of the colony must board and carefully watch all vessels arriving at the port, with the view to the powers conferred by the Act being put into operation.

4 Officers will be expected to exercise their powers with discretion, and not to interfere with any person without reasonable ground for believing that such person comes within one of the classes

of prohibited immigrants specified in section 3.

5. Section 3, sub-section (a), is to be put into operation mainly to the exclusion of Asiatics and Africans. Officers will be justified in requiring any Asiatic or African seeking to enter the Colony, or who may have made his way into, or, having arrived after the passing of the Act, may be found in the colony, to comply with sub-section (a).

6. If an officer has reason to believe that any prohibited immigrant is on board any vessel, he shall draw the attention of the master or other person in charge of the vessel to the fact, and to the consequences to the master and owners of the vessel upon any prohibited immigrant landing. (See

section 8.)

7. Any person who shall fail to comply with section 3 (a), or who shall appear to the officer to be a pauper or likely to become a public charge, must be prevented from landing from any vessel, or otherwise entering the colony, unless he shall comply with section 5 by depositing with the officer the sum of £100.

8. Any person coming within sub-sections (c), (d), (e), and (f) of section 3 must be prevented from landing or entering the colony absolutely. In case any prohibited immigrant shall escape the vigilance of officers, section 4 must be put in operation against the immigrant and section 8 against

the vessel, its master, and owners, in the case of arrival by sea.

9. In case there shall be occasion to put section 8 into force, officers will seek the assistance

of an officer of Customs, with the view to the vessel being refused a clearance.

10. Officers must observe sections 7 and 13 in connection with the exercise of powers under Section 3.

Arithmetic.—Plane Geometry, including the subjects treated in Euclid, Books I., II., III., IV., VI., and XI., to proposition 21 inclusive.

Algebra, as far as, but not including, the Theory of Numbers.

Plane Trigonometry, including De Moivre's Theorem and its simpler application.

Elementary Geometrical Conic Sections.

Analytical Geometry:—

- (a) Equations in Rectangular and Polar Co-ordinates of: (1) the straight line; (2) the Circle; (3) the Parabola; (4) the Ellipse; (5) the Hyperbola, and the properties of the same.
- (b) Change of Axis.
- 5. Applied Mathematics.

    - gnetism.—Simple experimental properties of magnets. Effect of a magnet on a neighbouring piece of soft iron or of hard steel. Terrestrial magnetism; behaviour of a declination needle and of a dipping needle at different parts of the earth's surface.
  - (c) Botany.—The elements of the Morphology and Physiology of the flowering plant. The parts of the flower and their functions with special reference to fertilization. Fruits and seeds, with their provisions for preservation and dispersion. Elementary facts in the nutrition of the flowering plant. Classification of flowering plants with special reference to the principal natural orders. The structure and properties of the cell treated from an elementary point of view. The description of the flowering plant in technical language. The paper will include questions on the Flora of Ceylon.
