GENERAL CONDITIONS APPLICABLE TO APPOINTMENTS TO POSTS IN THE LOCAL GOVERNMENT SERVICE ADVERTISED IN PART IV OF THE "CEYLON GOVERNMENT GAZETTE"

- 1. Allowances.—Unless otherwise stated Rent Allowance, temporary Cost of Living Allowance and temporary Special Living Allowance are payable according to Government Rates and Conditions.
- 2. Conditions of Service.—Appointments will be subject to the provisions of the Local Government Service Ordinance (Chapter 264), and any amendments thereof, and the Regulations made thereunder and other conditions of service as laid down by the Commission from time to time.
- 3. Terms of Engagement.—The posts specified in the Schedule published in Part IV of the Ceulon Government Gazette No. 10.432 of August 8, 1952, and other posts added thereto from time to time while held by members of the Local Government Service other that females are pensionable under the Local Government Service Pension Scheme Regulations, 1962.
- (a) The pension rights of officers serving under Government will be conserved if released under section 21 of the Government Minutes on Pensions, and transferred to pensionable posts in the Local Government Service.
- (b) In the case of employees of Local Authorities who hold pensionable posts under the Pension By-laws or Rules of the Local Authorities the payments of their pensions on ultimate retirement will be governed by the Pension By-laws or Rules of the Local Authority in whose employ they were on the date immediately preceding the date of their transfer to Local Government Service in terms of section 48 of the Local Government Service Ordinance. - (c) All appointees to pensionable posts other than females, officers above the age of 55 and officers who were holding pensionable posts in Government Service were holding pensionable posts in Government Service on the date immediately prior to their appointment to the Local Government Service, are required to contribute 4 per cent of their salary to the Local Government Service Widows' and Orphans' Pension Fund established under the Local Government Service Widows' and Orphans' Pension Fund Regulations, 1952, published in the Government Gazette Extraordinary No. 10.329 of July 30, 1952 The Local Authority will contribute 3 per cent. of salary.

Failure to pass these proficiency tests within the prescribed periods will result in the suspension of increments and if a test is not passed within a further period of time beyond the prescribed period suspension will be converted to stoppage, such stoppage operating until the test is passed (Vide conditions relating to the implementation of the Official Language Act, published in Gazette No. 13,387 of 9.11.62). - (c) Educational and other Qualifications.—In all Schemes of Recruitment where the minimum qualifications prescribed is a pass in the S.S.C. examination or equivalent or higher examination, a candidate who is a Sinhalese, educated in the Sinhala medium should have a pass in the Sinhala Language or its equivalent obtained at the Senior School Certificate or equivalent
- (d) Efficiency Bars.—New-Entrant Officers may be required to pass a prescribed Efficiency Bar test in the Sinhall Language of the Senior School Certificate standard within two years from the date of confirmation in the appointment. Failure to pass this test will resulted suspension in the first instance, stoppage in the second instance and deferment thereafter of the officer's increments officer's increments.
- (iv) New-Entrant Officers who qualify for entry into the Local Government Service through the Sinhala medium will be exempted from the Proficiency test in Sinhala
- (v) Provisions of Local Government Service Regulations 21 and 22 will apply if the prescribed standard of proficiency in Sinhala is not reached by the end of the period of probation/trial.
- "(Conditions (iii) (a), (b) and (v) above will apply to those recruited through the Tamii/English medium.)"
- Note.—The term "New-Entrant Officers" in this context means officers appointed to posts in the Local Government Service in response to advertisements published on or after 29th January, 1960.
- 5 Qualifications Required.—Every applicant must furnish satisfactory proof that he is a Ceylonese. The term "Ceylonese" for all purposes of recruitment to the Local Government Service is defined as a citizen of Ceylon by descent or by registration.

Examinations, Results of Examinations, &c.

LOCAL GOVERNMENT SERVICE

Examination for Recruitment to the Local Government Clerical Service—8th October, 1986

+ AREA 'B' ONLY

DATE of Examination.—(a) A competitive examination for male and female candidates wishing to enter the Local Government Clerical Service will he held in Kandy Anuradhapura, Badulla and Kurunegala, on 5th October, 1966. The Examination will be conducted by the Commissioner of Examinations.

- (b) Every candidate should state his/her first and second choice of centres in Cage 2 of the application form. Any centre for which a sufficient number of candidates do not enter may be cancelled.
- (c) A change of centre will not be permitted under any
- (d) 50 per cent. of the vacancies have been reserved for candidates mentioned in para. 8 of this notification provided they reach a certain standard in the written examination.

Note.—Only candidates who have been residents in Area 'B' specified in Second Schedule to the Local Government Service Ordinance (Cap. 265) need apply. (Vide para. 3 of the "Note" appearing at the end of this notification.)

2. Salary.—Successful candidates will be appointed as vacancies occur to posts in the Local Government Clerical Service to serve local authorities on the salary scale of Rs. 960 per annum rising by annual increments of Rs. 72 to Rs. 2,688 per annum. In this scale Efficiency Bars operate before Rs. 1,608 and Rs. 2,184 per annum. Rent allowance in accordance with Government rates and conditions, a temporary cost of living allowance and special living allowance at Government rates will be paid.

- 3. Conditions of Service.—(a) Male candidates who are successful in the Examination will be appointed on 3 years' probation with effect from the date of appointment. Their posts are pensionable. Female candidates who are successful in the examination will be appointed on a provident fund basis in the first instance and will be on trial for a period of three years' with effect from the date of appointment. They are entitled to opt to come into the pensionable establishment at any time before completing 10 years service. The option once exercised will be irrevocable. Those female candidates who exercise this option during the period of trial will candidates who exercise this option during the period of trial will be placed on probation thereafter, the period of probation being equivalent to that part of three years' trial period which they have not served.
- (b) Successful candidates who are holding permanent and pensionable posts in the Local Government Service, will be appointed on an acting basis in terms of Regulation 22 (2) of the Local Government Service Regulations and their confirmation in the posts will be considered at the end of the acting period. The acting period will be six months in the first instance.
- (c) The grant of leave and other conditions of service will be governed by the by-laws and regulations of the Local Authority, subject to the provisions of the Local Government Service Ordinance (Cap. 264) and any regulations framed thereunder.

- (J) Successful candidates who are appointed to a local authority (other than a Municipal Council) will be liable to transfer within Area 'B' specified in the Second Schedule to the above Ordinance, and may be posted to any station within Area 'B' in Ceyion. They will be required to pass a test in typewriting in terms of the Local Government Service Commission Circular No. 116 of December 8, 1961. They will be subject to the provisions of the Local Government Service Ordinance (Cap. 264), any further amendments of Ordinance, and any regulations made thereunder.
- (e) Successful candidates with previous continuous service in a local authority may be allowed incremental credit for such services.
- (f) Successful candidates will be required to comply with any rules already made or that may hereafter be made for giving effect to the Language Policy of the Government and, in particular, for implementing the provisions of the Official Language Act, No. 33 of 1956.
- 4. (a) The names of successful candidates will be published in Part IV of the Ceylon Government Gazette and they will be given appointments as and when vacancies occur.
- (b) Successful candidates may be appointed to any local authority, whether M.C., U.C., T.C., or V.C., situated within area 'B' specified in the Second Schedule to the Local Government Service Ordinance (Cap. 264) in terms of the Residential Certificate mentioned at para. 12 (i).
 - 5. Eligibility.—(i) Candidates must be of good character.
 - (ii) Candidates must be Ceylonese.*

- (c) G.C.E. (Ordinary Level) in six subjects which should have been passed on not more than two occasions including—

 - (ii) Arithmetic/Mathematics/Commercial Arithmetic.

Note.—APPLICATIONS WILL NOT BE ENTERTAINED FROM CANDIDATES WHO HAVE SAT FOR ANY OF THE EXAMINATIONS MENTIONED ABOVE, THE RESULTS OF WHICH HAVE NOT BEEN RELEASED BEFORE THE DATE OF CLOSING OF APPLICATIONS FOR THIS EXAMINATION.

- (iv) Candidates must be within the age limits laid down in para. 12 (iv) (a) of this notification.
- (v) Candidates should have been residents for at least three years immediately prior to 12th August, 1966, within area 'B' specified in the Second Schedule to the Local Government Service Ordinance.
- 6. Eligibility.—Special concessions to Civilian Employees of the British Services in Ceylon and ex-servicement of the Armed Forces.
- (i) Ceylonese Civilian Employees of the British Services in Ceylon who have been discharged on or after July 6, 1956, or who have been discharged consequent to the Government's taking over of the bases, and employees of the Royal Naval Wireless Station at Narahenpita (Anderson Station) who were discharged after September 27, 1954, as a result of the Government's decision to shift this station to Periyakarachchi in the Trincomalee District, will be eligible for the following concessions:—
 - (a) In computing age for the purpose of the age limit prescribed in paragraph 5 (iv) they will be allowed to deduct their period of service under the British Service provided such service was continuous and satisfactory.
 - (b) Those who have completed at least four years' continuous satisfactory service under the British Services on or before June 19, 1962, and who do not possess the educational qualifications specified in paragraph 5 (iii) will be permitted to sit for this Examination provided they have passed at least one of the following examinations:—
 - (i) J.S.C. (Sinhala/Tamil) of the Education Department,
 - (ii) J.S.C. (Sinhala/Tamil) of a school approved by the Education Department.
- (ii) Ex-servicemen of the Armed Forces will be eligible for the following concessions:—
 - (a) In computing age for the purposes of the age limit prescribed in paragraph 5 (iv) ex servicemen of the Armed Forces, viz., Reservists or Officers and Servicemen who have left the Armed Forces, except those who have been cashiered, dismissed, discharged with ignoring or had to leave the service for any sort of misconduct, will be allowed to deduct their periods of service in the Regular Force from their ages.

- (b) Those who count not less than four years' service in the Regular Force and who do not possess the educational qualifications specified in paragraph 5 (iii) will be permitted to sit for the examination provided they have passed at least one of the examinations mentioned in paragraph 6 (i) (b).
- 7. Eligibility.—Special concessions to those already employed in the Local Government Service—

Persons holding permanent posts in the Local Government Service on 12th August, 1966, and persons in the permanent employment of a Local Authority and Temporary Clerks in Local Authorities with not less than 2 years's salisfactory service will be permitted to sit for this examination irrespective of age, provided they possess the educational qualifications prescribed in paragraph 5 (iii) (a), (b) or (c).

- 8. Eligibility.—Special concessions to Minor Employees-
- (i) Local Government Service Minor Employees .-

Minor Employees falling within the two categories (a) and (b) below, holding permanent posts in the Local Government Service, who have been confirmed in their appointments with 5 years satisfactory service on or before 12th August, 1966, are eligible to sit for this examination irrespective of educational qualifications and age mentioned in paragraphs 5 (iii) and 12 (iv) (a).

- (a) those on fixed salaries below Rs. 888 per annum or on salary scales, the initial salaries of which are below Rs. 888 per annum and the maximum does not exceed Rs. 1,842 per annum.
- (b) those on salary scale, the initial salaries of which do not exceed Rs. 1,170 per annum and the maximum does not exceed Rs. 1,842 per annum provided that they are not 'direct' recruits to posts/grades on such scales but are 'promotees' from posts/grades referred to at (a) above.
- (ii) Non-Local Government Service Minor Employees .-

Minor Employees holding permanent posts in Local Authorities with not less than 5 years' satisfactory service on or before 12th August, 1966, are eligible to sit for this examination irrespective of educational qualifications and age mentioned in paragraphs 5 (iii) and 12 (iv) (a).

- 9. Trolley Bus Drivers and Conductors who were in the service of the Passenger Transport Department of the Colombo M.C. and retired for abolision of office, are eligible to sit for this examination, provided they possess the qualifications mentioned in paragraph 5 (iii) and are not over 50 years of age on 12th August, 1986
- 10. Eligibility.—Special concession to Temporary Clerks in the Government Service—
