The Rules made under the Council of Legal Education Incorporation Ordinance, as last amended by notification dated August 27, 1965, published in the Ceylon Government Gazette No. 14,501 of September 9, 1965, were further amended at a meeting of the Council of Legal Education held on October 22, 1965, as

(a) Rule 23 (3) (iv), by the addition at the end thereof of the following: -

"and a Graduate of the said Faculty who has been duly admitted and enrolled as a Proctor of the Supreme Court shall be exempted from the Entrance Examination."

(b) Rule 51, by the addition at the end of clause (a) thereof of the following: -

> "and in the case of a person called to the Bar on or after 1st June, 1965, he attends, before or after passing the said examination, for a period of six months the chambers of an Advocate of ten years' standing practising in Colombo and also attends, before or after passing the said examination, for the same period the District Court of Colombo and the Supreme Court for the purposes and in the manner set out in Rule 36 for an Advocate student who has passed the Final Examination. Provided, however, that if a person called to the Bar in England on or after 1st June, 1965, has served a period of pupillage in England under a practising barrister for not less than six months or has undergone a Practical Training Course established by the English Council of Legal Education for not less than six months he shall be exempted, upon documentary proof thereof, from attending chambers and attending Courts as aforesaid."
