10. This Land Kachcheri will be confined only to the unemployed youth in the Trincomalee District. Preference will however be given to those from the Muttur Electorate. Every applicant should have at least passed the 8th standard in Sinhala, Tamil or English and should be able to produce documentary proof with regard to his educational qualifications. They should also produce the rice ration books of the present series or any other documents in proof of their permanent residence within the Trincomalee District and should be prepared to prove citizenship if required.

11. The selectees will be settled in any one of the schemes referred to in Schedule 'A'.

12. These schemes are meant solely for the settlement of unemployed youth. If after selection any allottee secures employment whether under Government or otherwise and leaves the scheme his allotment will be cancelled.
