IMPORT CONTROL NOTICE No. 26/65

Licences under the U. K./Ceylon Loan, 1965

IT is proposed to issue special licences for the import of fertilisers, commercial vehicles and spares, engineering stores, building materials, industrial raw materials and machinery from the U. K. under the U. K./Ceylon Loan, 1965.

- 2. All imports under the U. K./Ceylon Loan, 1965, shall be against Letters of Credit.
- 3. The following procedure will apply as regards licences issued under this scheme and will be complementary to that already in force:—
 - (i) On receipt of a special allocation or authorisation which will be headed "U. K./Ceylon Loan, 1965", the importer will open negotiations with his Supplier in the U. K. and on completion of a Contract will instruct his Supplier to forward immediately to the Crown Agents for Oversea Governments and Administrations, 4 Millbank, London, S. W. I., England, three copies of the Contract and Contract Certificate (in the form set out in the Appendix below), quoting reference to the Import Control Department allocation number.
 - (ii) After examination of the documents the Crown Agents will advise approval of the Contract and of the Contract Certificate to the Controller of Imports and Exports, Colombo, who will communicate this approval to the importer, who will then forward an Indent, in quadruplicate (in the form set out in Import Control Notice No. 19/62) in terms of the Contract entered into with his U. K. Supplier for licensing.
 - (iii) On receipt of his licence the importer will request his bank to open an irrevocable Letter of Credit in favour of his U. K. Supplier.
 - (iv) The U. K. Supplier will ship the goods to the Ceylon importer and will present the documents required by the Letter of Credit to the correspondent Bank in the U. K., who will make payment and then submit the invoice and payment certificates to the Crown Agents for reimbursement in sterling and following this will forward the original documents to the importer's bank in Ceylon.
 - (v) Thereafter clearance will take place in accordance with normal procedure, but declaration forms will be marked "U. K./Ceylon Loan, 1965" on the top left-hand corner in block capitals.
 - 4. It should be noted that-
 - (i) imports under these arrangements are restricted to goods wholly produced or manufactured in the United Kingdom
 and the beneficiary under the Contract must be a person carrying on business in the U. K. (including the Channel
 Islands and the Isle of Man);
 - (ii) where the transactions are on a c.i.f. basis, the whole amount may be covered under the loan. In the case of f.o.b. contracts shipping arrangements must be made with a British firm and insurance, if not effected with the Insurance Corporation of Ceylon, must also be arranged with a British company.
