EXPORT CONTROL NOTICE No. 6/66

Export of Goods by Post

EXPORT Control Notice No. 4/63 of May 3, 1963, is hereby cancelled.

(a) Goods produced or manufactured in Ceylon and not exceeding Rs. 50 in value may be sent to any country other than India without a licence from the Export Control Department. A licence from the Exchange Control Department should however be obtained for these goods, if the value of such

(b) Goods other than those referred to at (a) above require a licence from the Export Control Department. A licence from the Exchange Control Department is also required for these goods, if the value of such goods, exceeds Rs. 10.

(c) Articles of Platinum, Gold, Silver, Precious Stones, Rice and Flour require a licence from the Export and Exchange Control Departments.

(d) A licence from the Export Control Department should be obtained for all bona-fide gifts sent to India irrespective of the value.

2. Commercial Samples

(a) Goods produced or manufactured in Ceylon not exceeding Rs. 50 in value and not containing articles of Platinum, Gold, Silver, Precious Stones, Rice and Flour may be sent to any country other than India without a licence from the Export and Exchange Control Departments.
(b) Articles of Platinum, Gold, Silver, Precious Stones, Rice and Flour or any goods other than those referred to at (a) above require a licence from the Export and Exchange Control Departments.
(c) A licence from the Export Control Department should be obtained for all commercial samples sent to India, irrespective of the value.

3. Locally printed publications

Licences are not required for the export to countries other than India of locally printed publications such as Annuals, Magazines and Pamphlets.

4. Manufactured articles sent for repairs and return

No licence is required from the Export Control Department for the export to any country other than India of manufactured articles, valued up to Rs. 100 for repairs and return but a licence should be obtained from the Exchange Control Department.

5. Films sent for processing, development and printing

No licence is required from the Exchange Control Department for the export of films for processing, development, printing, and return but a licence should be obtained from the Export Control Department.

6. Miscellaneous Items

No licences are required from the Export and Exchange Control Departments for the export to any country other than India of the following items:—

(a) Account Books sent abroad for accounting purposes.
(b) Samples up to the value of Rs. 50 sent abroad for examination, inspection, etc.
(c) Tutorials and answer scripts sent abroad for correction etc.
(d) Bona-fide scientific specimens up to the value of Rs. 50.
(e) Tapes, wires, discs or other similar materials bearing sound recordings up to the value of Rs. 50 by bona-fide tourists—passengers and foreign commercial travellers.

7. Export of Goods by tourists, transit passengers or members of ships' crew

No licence is required from the Export and Exchange Control Departments for the export of goods produced or manufactured in Ceylon purchased ashore by tourists, transit passengers and members of ships' crew with funds brought in by them, provided such monies are declared to the Customs on arrival and documentary evidence thereof, furnished to the Postal Authorities. A licence is however required from the Export and Exchange Control Departments for the export of articles of Platinum or Gold or Silver, Precious Stones and Jewellery.
