#### LAND SETTLEMENT ORDINANCE

Settlement Order No. 1,347 (Kurunegala)

2. The upset rent will be Rs. 150. No bid below the upset rent will be accepted.

3. The Government Agent may, before accepting any bid, satisfy himself on the bona fides of the person making it and his ability to comply with the conditions of the lease. If he is not so satisfied, the Government Agent may refuse to accept such bid and continue the sale as if no such bid has been made.

4. Every bidder shall be present in person or by a duly accredited agent at the sale. In all cases of bids being made by agents the letter of authority from the principal should be produced to the Government Agent for scrutiny, before the commencement of the auction.

- (i) The licensee shall not have or make any claim for compensation for improvements effected or expenses incurred, or for damages or on any other account.
- (j) The licensee shall not have any claim to preferential sale or lease of the land by reason of this licence.
- (k) If a portion or whole land is required by the crown at a later date a proportionate refund of the lease rent will be made to the lessee.
