#### THE CEYLON (PARLIAMENTARY ELECTIONS) ORDER IN COUNCIL, 1946

##### Notice under section 82D (1) (b)

WHEREAS the Election Judge who tried the election petition complaining of the election and return of Mr. Wemullawatte Percy Samaraweera as member for Electoral District No. 126—Welimada, has certified, under section 81 of the Ceylon (Parliamentary Elections) Order in Council, 1946 (Chapter 381), that he has determined that the election of Mr. Wemullawatte Percy Samaraweera was void, I, William Gopallawa, Governor-General, in pursuance of the powers vested in me by section 82D (1) (b) read with section 27 of that Order in Council, do by this notice—

- (1) order the holding of an election in the aforesaid electoral district, and
- (2) specify 30th December, 1966, as the date, and the Kachcheri at Badulla as the place, for the nomination of candidates for such election.
