THE CONTROL OF PRICES ACT

Order

BY virtue of the powers vested in me by section 4 of the Control of Prices Act (Chapter 173), I, Deraniyagalage Basil Ivor Peiris Samaranayake Siriwardhana, Controller of Prices (Miscellaneous Articles), do hereby amend the Control of Prices (imported textiles and imported manufactures of textiles) Order No. 5 of 1966, published in *Gazette Extraordinary* No. 14,707/12 of August 10, 1966, as amended by Order published in *Ceylon Government Gazette Extraordinary* No. 14,712/2 of 14.9.1966 by substitution, for Schedule A to that Order, of the following Schedule.

IMPORT CONTROL NOTICE No. 35/66

Payment of freight and insurance charges on Imports

ALL importers who are issued licences by this Department for the import of goods of any description whatsoever are hereby notified that commencing with licences issued on letters of allocation dated 31.3.67 and thereafter, the invoices in respect of goods imported on the import licences should separately specify the amount paid as freight and insurance.

2. The sale price of the goods charged by the supplier should be shown separately without the freight and insurance being added thereto as is the current general practice.

3. It is important that the cost of insurance and cost of freight should be shown as separate and independent items in the import documents.
