Electoral District No. 17-Kolonnawa

Report in Terms of Section 82 of the Ceylon (Parliamentary Elections) Order in Council, 1946

In terms of section 82 of the Ceylon (Parliamentary Elections) Order in Council, 1946, I, do hereby, at the conclusion of the trial of Election Petition No. 6 of 1965, report that—

Don Senadheera Samarasinghe, a candidate at the election held on the 22nd day of March, 1965, to elect a Member to represent Electoral District No. 17—Kolonnawa, in the House of Representatives, has been proved to have committed three offences of bribery within the meaning of section 57 (b) of the said Parliamentary Elections Order in Council, to wit:—

- (1) That between the 20th day of December, 1964, and the 2nd day of January, 1965, he did procure employment for one Hettiarachchige Sirisena at the Government Industrial Exhibition held at Colombo in order to induce the said Sirisena to vote;
- (2) That between the 8th and 10th days of January, 1965, he did procure employment for one B. M. Cooray at the Government Industrial Exhibition held at Colombo in order to induce the said Cooray to vote;

(3) That between the 10th and 14th days of January, 1965, he did procure employment for one M. G. Dharmadasa at the Government Industrial Exhibition held at Colombo in order to induce the said Dharmadasa to vote.
