Local Government Notifications

THE MUNICIPAL COUNCILS ORDINANCE

Order

BY virtue of the powers vested in me by sections 2, 5, 6 and 9 of the Municipal Councils Ordinance (Chapter 252), I, Murugesen Tiruchelvam, Minister of Local Government, do by this Order—

- (1) declare the area delimited in the First Schedule hereto to be a Municipality for the purposes of that Ordinance ;
- (2) define the limits of that Municipality to be the limits set out in that Schedule ;
- (3) assign to the Municipal Council to be constituted for that Municipality, the following name and designation, namely, the " Batticaloa Municipal Council " ;
- (4) prescribe that the Batticaloa Municipal council shall consist of nineteen Councillors ;
- (5) divide the area for which the Batticaloa Municipal Council is to be constituted into nineteen wards with the limits as defined in the Second Schedule hereto ; and
- (6) appoint April 1, 1967, as the date on which the term of office of the Batticaloa Municipal Council shall commence.

FIRST SCHEDULE

LIMITS OF THE MUNICIPALITY OF BATTICALOA

All that area of land served by (1) Puliyantivu, (2) the peninsula from Kallady Bridge up to the new Boundary Road and (3) the peninsula from Navalady up to the northern limit of Kattankudy Town Council in Batticaloa District, Eastern Province and bounded as follows :—

- (1) The whole area of Puliyantivu surrounded by Batticaloa Lake.
- (2) *North and East* : By a line drawn from the point of intersection of the northward prolongation of the western boundary of New Boundary Road and the edge of Batticaloa Lake South-eastward and south-westwards along the edge of Batticaloa Lake to the centre line of Trincomalee Road.
South : By a line drawn from the last mentioned point north-westwards along the edge of Batticaloa Lake up to the southward prolongation of the western boundary of New Boundary Road.
West : By a line drawn from the last mentioned point north-eastward along the said prolongation and the western boundary of the said road and along its northward prolongation to the starting point of the northern limit of the area.
- (3) *North and East* : By a line drawn from the northern most point of the peninsula, eastwards and south-eastwards along the said Low Water Mark up to the northern limit of Kattankudy Town Council.

South : By a line drawn from the last mentioned point westwards, southwards and again westwards along the northern limit of Kattankudy Town Council to the edge of Batticaloa Lake.

West : By a line drawn from the last mentioned point northwards and north-westwards along the edge of Batticaloa Lake to the starting point of the north-eastern limit of the area.

SECOND SCHEDULE

LIMITS OF WARDS OF BATTICALOA MUNICIPAL COUNCIL Ward No. 1

North : By a line drawn from the point of intersection of the eastern boundary of Trincomalee Road and the northern boundary of Customs road eastwards along the edge of Batticaloa Lake to the pier of the former Kallady Ferry.

East : By a line drawn from the last mentioned point South-westwards along the edge of Batticaloa Lake till it meets the South-Eastward prolongation of the centre line of the P. W. D. road.

South and West : By a line drawn from the last mentioned point north-westwards along the centre line of P. W. D. road to the centre line of Chapel Street ; thence northwards along the centre line of Chapel Street to the centre of its junction with Mission Lane ; thence westwards and southwards along the centre line of the said lane to the centre line of Tamarind Lane ; thence westwards along the centre line of Tamarind Lane to the centre of its junction with Central Road ; thence northwards along the centre line of Central road to the starting point of the northern limit of the ward.

Ward No. 2

North : By a line drawn from the point of intersection of the eastern boundary of Covingtons Road and the northern boundary of the premises bearing Assessment Nos. 74, 72, 70, eastwards along the southern boundary of the said premises to the western boundary of premises bearing Assessment Nos. 68 and 64 ; thence northwards along the said boundary to the northern boundary of the said premises ; thence eastwards along the northern boundary of the said premises to the western boundary of premises bearing Assessment No. 64/3 ; thence northwards along the western boundaries of premises bearing Assessment Nos. 64/3 and 64/4 and eastwards along the northern boundary of the latter mentioned premises to the eastern boundary of premises bearing Assessment No. 59 ; thence northwards along the eastern boundaries of the said premises and that of 55 to the northern boundary of premises bearing Assessment Nos. 64/7, 64/8 and 64/9 ; thence eastwards along the northern boundary of said premises and southwards along the eastern boundary of same and premises bearing assessment No. 64/10 and 62 to the northern boundary of the Cemetery bearing Assessment No. 58 ; thence eastwards along the said northern boundary and its prolongation to the eastern boundary of 2nd Cross Street ; thence southwards along the eastern boundary of the said Street to the

northern boundary of premises bearing Assessment Nos. 52 and 52/1; thence eastwards along the northern boundary of the said premises and that of 48 to the western boundary of premises bearing Assessment No. 42; thence northwards and eastwards along the western and northern boundaries and southwards along the eastern boundary of the said premises to the northern boundary of premises bearing Assessment No. 36; thence eastwards along the northern boundaries of premises bearing Assessment Nos. 36 and 32 to the eastern boundary of the latter mentioned premises; thence southwards along the eastern boundary of the said premises to the northern boundary of Hospital Road; thence eastwards along the said northern boundary to the eastern boundary of Central Road; thence northwards along the eastern boundary of the said Road to the southern boundary of premises bearing Assessment No. 137; thence eastwards along the said southern boundary and northwards along the eastern boundary of said premises to the southern boundary of premises bearing Assessment No. 131; thence eastwards along the southern boundary and northwards along the eastern boundaries of premises bearing Assessment Nos. 131, 127 and 115 and westwards and northwards along the northern boundary of the latter mentioned premises to the southern boundary of Dhobies Street (Green Street); thence north-eastwards along a straight line up to the south-eastern corner of premises bearing Assessment No. 109; thence northwards along the eastern boundaries of premises bearing Assessment Nos. 109, 107, 105, 101, 99, 97 and 95 to the northern boundary of latter mentioned premises; thence westwards along the said northern boundary and its prolongation to the centre line of Central Road; thence northwards along the said centre line to the south-western limit of Ward No. 1.

East: By a line drawn from the last mentioned point southwards and south-eastwards along the south-western limit of Ward No. 1 to the edge of Batticaloa Lake.

South: By a line drawn from the last mentioned point south-westwards along the edge of the Batticaloa Lake to the south-western corner of premises bearing Assessment Nos. 23 and 29.

West: By a line drawn from the last mentioned point northwards along the western boundary of premises bearing Assessment Nos. 23 and 29 up to the southern boundary of Lake Road No. 2; thence northwards by a straight line up to the south-western corner of premises bearing Assessment No. 88; thence eastwards and northwards along the southern and eastern boundaries of said premises to its northern boundary; thence westwards along the northern boundaries of premises bearing Assessment Nos. 88, 90, 96, 102 and 102/1 to the western boundary of western premises bearing Assessment No. 52/3; thence northwards along the said western boundary and that of 52/5 and eastwards along the northern boundary of the latter premises and that of 52/3 to the southward prolongation of the western boundary of premises bearing Assessment No. 52/6; thence northwards along the said western boundary and that of 46/2 to the northern boundary of the latter mentioned premises; thence eastwards along the northern boundary of the said premises and that of 46/4 to the western boundary of premises bearing Assessment Nos. 36 and 38; thence northwards along the western boundary of the said premises to the southern boundary of premises bearing Assessment No. 32; thence westwards along the southern boundary and northwards along the western boundary of the said premises and that of premises bearing Assessment No. 23 up to the northern boundary of premises bearing Assessment No. 24; thence westwards along the northern boundaries of premises bearing Assessment Nos. 24, 20 and 16 to the north-western corner of the latter mentioned premises; thence north-westwards by a straight line up to the south-western corner of premises bearing Assessment Nos. 21 and 29; thence northwards along the western boundary of the said premises up to the northern boundary of premises bearing Assessment No. 15; thence westwards along the northern boundaries of premises bearing Assessment Nos. 15, 11, 7, 5, 17/1 and 17 up to the eastern boundary of 3rd Cross Street; thence northwards along the eastern boundary of the said street up to the north-western corner of Annaipanthipilaiyar Temple premises; thence northwards along a straight line up to the south-western corner of premises bearing Assessment Nos. 74, 72 and 70; thence northwards along the western boundary of the said premises to the starting point of the northern limit of the ward.

Ward No. 3

North: By a line drawn from the point of intersection of the eastern boundary of Lake Road No. 1 and the northern boundary of premises bearing Assessment No. 170 eastwards along the said northern boundary and that

of premises bearing Assessment Nos. 162, 160, 158 to the eastern boundary of the same premises thence southwards along the said eastern boundary to the northern boundary of premises bearing Assessment No. 150; thence eastwards along the northern boundary and southwards along the eastern boundary of the said premises to the northern boundary of premises bearing Assessment Nos. 144 and 142; thence eastwards along the said northern boundary and its prolongation to the eastern boundary of Suriya Lane; thence northwards along the eastern boundary of the said lane to the northern boundary of premises bearing Assessment No. 138; thence eastwards along the northern boundary of the said premises and its prolongation to the eastern boundary of Hospital Lane; thence eastwards along the eastern boundary of the said Lane to the northern boundary of premises bearing Assessment No. 132; thence eastwards along the northern boundary of one said premises to the western boundary of premises bearing Assessment No. 122/5; thence northwards and eastwards along the western and northern boundary of said premises and along the northern boundaries of premises bearing Assessment Nos. 122/9, 112, 110, 108, 106 and 100 to the western boundary of premises bearing Assessment Nos. 88/1, 88, 84, 82/1 and 82; thence northwards along the western boundaries of said premises to the southern boundary of Angle Road; thence eastwards along the southern boundary of the said road and its prolongation to the western limit of ward No. 2.

East: By a line drawn from the last mentioned point southwards, eastwards, and again southwards along the western limit of Ward No. 2 to its northern extremity.

South and West: By a line drawn from the last mentioned point south-westwards southwards, north-westwards along the edge of Batticaloa Lake to the centre line of Lake Road No. 1; thence north-eastwards along the centre line of the said road to the starting point of the northern limit of the ward.

Ward No. 4

North: By a line drawn from the point of intersection of the eastern boundary of Lake Road No. 1 and the northern boundary of premises bearing Assessment No. 52 eastwards along the northern boundary of premises and that of premises bearing Assessment Nos. 48, 44/1 and 40 to the eastern boundary of the latter mentioned premises; thence northwards along the said eastern boundary to the northern boundary of premises bearing Assessment No. 36; thence eastwards along the northern boundaries of the said premises and that of 32/1 to the north-eastern corner of the latter mentioned premises; thence eastwards by a straight line to the north western corner of premises bearing Assessment No. 30; thence eastwards along the northern boundaries of premises bearing Assessment Nos. 30 and 26 to the western boundary of premises bearing Assessment No. 16; thence northwards along the western boundary and eastwards along the northern boundary of the said premises and that of 10 to the western boundary of premises bearing Assessment No. 8; thence northwards along the western boundary of the said premises to its northern boundary; thence eastwards along the northern boundary and southwards along the eastern boundary of the said premises to the northern boundary of premises bearing Assessment No. 4; thence eastwards along the said northern boundary and that of 2 to the eastern boundary of the latter; thence southwards along the eastern boundary of the said premises to the northern boundary of Upstair Road; thence eastwards along the northern boundary of the said road and its prolongation to the eastern boundary of Covington Road.

East: By a line drawn from the last mentioned point southwards along the eastern boundary of Covington Road to the northern boundary of Magiladi Road; thence eastwards along the northern boundary of the said road to the northward prolongation of the eastern boundary of premises No. 39; thence southwards along the said prolongation and the eastern boundaries of premises bearing Assessment Nos. 39, 43, 47 and 51 to the northern limit of ward No. 2 (northern boundary of premises bearing Assessment Nos. 64/7, 64/8 and 64/9); thence southwards along the northern limit of Ward No. 2 to the eastern extremity of the northern limit of Ward No. 3.

South: By a line drawn from the last mentioned point southwards along the northern limit of Ward No. 3 to its western extremity; thence westwards along the centre line of Lake Road No. 1 to the edge of Batticaloa Lake.

West: By a line drawn from the last mentioned point northwards, south-eastwards, and north-eastwards along the edge of Batticaloa Lake to the starting point of the northern limit of the ward.

Ward No. 5

North and West : By a line drawn from the starting point of the northern limit of Ward No. 4 north-eastwards along the edge of Batticaloa Lake to the centre line of Central Road.

East : By a line drawn from the last mentioned point southward along the centre line of Central Road to the northern limit of Ward No. 2; thence southwards along the said northern limit to the northern boundary of Hospital Road at its junction with Central Road.

South : By a line drawn from the last mentioned point westwards along the northern boundary of Ward No. 2 to the southern extremity of the eastern boundary of Ward No. 4; thence northwards along the eastern boundary and westwards along the northern boundary of the said ward to the starting point of the northern limit of the ward.

Ward No. 6

North : By a line drawn from the point of intersection of the centre line of Trincomalee Road and the westward prolongation of the northern boundary of Old Rest House Road eastwards along the said prolongation and the said northern boundary to the eastern boundary of premises bearing Assessment No. 26; thence northwards along the said eastern boundary to the southern boundary of premises bearing Assessment Nos. 32 and 32/1; thence eastwards along the southern boundaries of premises bearing Assessment Nos. 32, 32/1, 36, 38, 42, 50, 52, 54 to the western boundary of premises bearing Assessment No. 87/2.

East : By a line drawn from the last mentioned point southwards along the western boundaries of premises bearing Assessment Nos. 87/2 and 87/1 and eastwards along the southern boundaries of premises bearing Assessment No. 87/1 and that of the lane leading from Pioneer Road the north-western corner of premises bearing Assessment No. 81; thence southwards along the western boundary of premises bearing Assessment No. 81 to the northern boundary of Old Rest House Road; thence southwards along a straight line to the north-western corner of premises bearing Assessment No. 71; thence southwards along the western boundary of said premises to the northern boundary of premises bearing Assessment No. 67; thence westwards along the northern boundary of the said premises and that of 61/2 to the western boundary of the latter; thence southwards along the western boundaries of premises bearing Assessment Nos. 61/1, 61/2, 55/1, 55, 53, 49/1 and 43 to the northern boundary of Collette Lane; thence south-westwards along a straight line to the north-western corner of premises bearing Assessment Nos. 39 and 37; thence southwards along the western boundary and eastwards along the southern boundary of the said premises to the western boundary of premises bearing Assessment No. 33; thence southwards along the western boundaries of premises bearing Assessment Nos. 33, 31, 27 and 25 to the northern boundary of Moor Street; thence south-eastwards along a straight line to the north-western corner of premises bearing Assessment No. 17; thence southwards along the western boundaries of premises bearing Assessment Nos. 17, 15, 11 and 9 to the northern boundary of Arasady Pillaiyar Lane; thence south-eastwards along a straight line to the north-western corner of premises bearing Assessment No. 5; thence southwards along the western boundaries of premises bearing Assessment Nos. 5 and 3 to the southern boundary of the latter; thence eastwards along the said southern boundary to the western boundary of Pioneer Road; thence southwards along the western boundary of the said road and its prolongation to the edge of Batticaloa Lake.

South : By a line drawn from the last mentioned point westwards along the edge of Batticaloa Lake till it meets the centre line of Trincomalee Road.

West : By a line drawn from the last mentioned point north-eastwards and north-westwards along the centre line of Trincomalee Road to the starting point of the northern limit of the Ward.

Ward No. 7

North : By a line from the point of intersection of the eastern boundary of Bar Road and the northern boundary of Baily Cross Street eastwards along the northern boundary of the said street to the western boundary of premises bearing Assessment No. 11; thence northwards along the western boundary of the said premises to its northern boundary; thence south-eastwards along the northern boundaries of premises bearing Assessment Nos. 11, 21/5, 31/4, 31/10, 31/13 and 41 to the western boundary of premises bearing Assessment No. 15/1; thence north-eastwards along the western boundary of said premises to the western boundary of the lane leading from Baily Road No. 2; thence southwards along the western boundary of the said

Lane till it meets the westwards prolongation of northern boundary of premises bearing Assessment Nos. 21 and 25; thence eastwards along the said prolongation and the northern boundary of the said premises and that of 29, 35/1, 35/2 to the eastern boundary of the latter; thence southwards along the eastern boundary of the said premises and along the western boundary or premises bearing Assessment Nos. 31 and 31/1 to the northern boundary of Laly Road No. 2; thence eastwards along the northern boundary of the said road and its prolongation to the edge of Batticaloa Lake.

East and South : By a line drawn from the last mentioned point south-westwards along the edge of Batticaloa Lake till it meets the eastern extremity of the southern limit of Ward No. 6.

West : By a line drawn from the last mentioned point northwards along the eastern limit of Ward No. 6 to its northern extremity thence eastwards along the southern boundaries of premises bearing Assessment Nos. 60, 62, 66, 66/1, 76 and 76/1 to the western boundary of Pioneer Road; thence northwards along the said western boundary to the southern boundary of Bar Road; thence eastwards along the eastward prolongation of the said southern boundary to the eastern boundary of Bar Road; thence northwards along the eastern boundary of Bar Road to the starting point of the northern limit of the Ward.

Ward No. 8

North and East : By a line drawn from the point of intersection of the northward prolongation of Bar Road and the edge of Batticaloa Lake South-eastwards, north-westwards, eastwards, south-eastwards and southwards along the edge of said Lake to the eastern extremity of the northern limit of Ward No. 7.

South : By a line drawn from the last mentioned point north-westwards along the northern limit of Ward No. 7 to the eastern boundary of Bar Road.

West : By a line drawn from the last mentioned point northwards along the eastern boundary of Bar Road till it meets the eastward prolongation of the southern boundary of premises bearing Assessment Nos. 169, 171 and 171/1; thence westwards and northwards along the southern and western boundaries of said premises to the southern boundary of Lane leading from Bar Road to Old Boundary Road; thence north-westwards along a straight line to the south-western corner of premises bearing Assessment Nos. 195/1 and 197; thence northwards along the western boundaries of premises bearing Assessment Nos. 195/1, 197, 205, 209, 217, 219 and 221 to the southern boundary of premises bearing Assessment Nos. 225 and 235; thence westwards along the said southern boundary to the eastern boundary of Old Boundary Road; thence northwards along eastern boundary of the said road and its prolongation to the northern boundary of Pillaiyar Kovil Road; thence westwards along the said northern boundary to the western boundary of premises bearing Assessment No. 245; thence northwards along the western boundaries of premises bearing Assessment Nos. 245, 251, 255, 257, 265, 269 and 273 to the southern boundary of Mamankam Road; thence north-eastwards by a straight line to the south-eastern corner of premises bearing Assessment Nos. 4 and 6; thence northwards along the western boundary of Bar Road to the western boundary of premises bearing Assessment No. 281; thence north-westwards along the western boundaries of the said premises and that of 287 and 289 to the northern boundary of the latter mentioned premises; thence eastwards along the northern boundary of the said premises to the western boundary of premises bearing Assessment Nos. 291, 291/1 and 293; thence northwards along the western boundary of the said premises to its northern boundary; thence eastwards along the northern boundaries of said premises and that of 295 to the western boundary of Bar Road; thence eastwards along a straight line through the centre of Sedlamunai Junction to the starting point of the north-eastern limit of the ward.

Ward No. 9

North : By a line drawn from the point of intersection of the eastern boundary of Old Boundary Road and the westward prolongation of the northern boundary of premises bearing Assessment Nos. 60, 60/1 and 60/2 eastwards along the said prolongation and the northern boundaries of premises bearing Assessment Nos. 60, 60/1, 60/2, 50, 54, 54/1, 44 and 44/1, 44/2, 30, 36, 36/1, 22 and 6 and along the eastward prolongation of the latter mentioned premises to the eastern boundary of Bar Road.

East : By a line drawn from the last mentioned point southwards along the western limits of Wards Nos. 8 and 7 to the eastern extremity of the northern limit of Ward No. 6.

South : By a line drawn from the last mentioned point south-westwards along the northern limit of Ward No. 6 to its western extremity; thence north-westwards along the centre line of Trincomalee Road till it meets the southward prolongation of the eastern boundary of Old Boundary Road;

West : By a line drawn from the last mentioned point northwards along the said prolongation and the said eastern boundary to the southern boundary of premises bearing Assessment No. 6; thence eastwards along the said southern boundary and northwards along its eastern boundary and that of 10 to the northern boundary of the latter mentioned premises; thence westwards along the said northern boundary to the eastern boundary of premises bearing Assessment Nos. 16, 16/1, 16/2, 16/3, 16/4 and 20; thence northwards along the said eastern boundary to the southern boundary of premises bearing Assessment No. 26; thence eastwards along the southern boundary northwards along the eastern boundary and westwards along the northern boundary to the eastern boundary of premises bearing Assessment Nos. 32 and 32/1; thence northwards along the eastern boundaries of premises bearing Assessment Nos. 32, 32/1, 36, 46/2, 46/1, 48, 50, 52, 52/1, 52/2 and 54 to the southern boundary of premises bearing Assessment Nos. 56, 56 1/1 and 58 (Government Training College); thence eastwards along the southern boundary, northwards along the eastern boundary and westwards along the northern boundary of the said premises to the eastern boundary of premises bearing Assessment No. 60; thence northwards along the eastern boundary of the said premises and that of 68, 70, 72, 74 76 and 78 to the northern boundary of the latter mentioned premises; thence westwards along the northern boundary of the said premises to the eastern boundary of Old Boundary Road; thence northwards along the eastern boundary of the said road to the starting point of the northern limit of the ward.

Ward No. 10

North : By a line drawn from the point of intersection of the westward prolongation of the centre line of Trincomalee Road and the edge of Batticaloa Lake eastwards and south-eastwards along the said prolongation and the centre line of the said road to the northern extremity of the western limit of Ward No. 6.

East : By a line drawn from the last mentioned point south-westwards along the western limit of Ward No. 6 to its southern extremity.

South and West : By a line drawn from the last mentioned point north-westwards along the edge of Batticaloa Lake to the starting point of the northern limit of the Ward.

Ward No. 11

North : By a line drawn from the point of intersection of the south-westward prolongation of the centre line of Mani Lane and the edge of Batticaloa Lake north-eastwards along the centre line of Mani Lane to the centre line of Kumarar Kovil Road; thence north-eastwards along the centre line of the said road to the centre line of the railway track; thence south-eastwards along the centre line of the railway track to the western limit of Ward No. 9.

East : By a line drawn from the last mentioned point southwards along the western limit of Ward No. 9 to its southern extremity.

South and West : By a line drawn from the last mentioned point north-westwards along the northern limit of Ward No. 10 to the edge of Batticaloa Lake; thence north-westwards along the said edge to the starting point of the northern limit of the Ward.

Ward No. 12

North : By a line drawn from the point of intersection of the centre line of the railway track and the centre line of Pillaiyar Kovil Road south-eastwards along the centre line of the said road to the western limit of Ward No. 8.

East : By a line drawn from the last mentioned point southwards along the western limit of Ward No. 8 to the eastern extremity of the northern limit of Ward No. 9.

South : By a line drawn from the last mentioned point westwards along the northern limit and southwards along the western limit of Ward No. 9 to the centre line of the railway track.

West : By a line drawn from the last mentioned point north-westwards along the centre line of the railway track to the starting point of the northern limit of the Ward.

Ward No. 13

North : By a line drawn from the point of intersection of the western boundary of the New Boundary Road and the centre line of the railway track south-eastwards along the centre line of the railway track to the centre line of Kumarar Kovil Road.

East : By a line drawn from the last mentioned point south-westwards along the northern limit of Ward No. 11 to its western extremity.

South : By a line drawn from the last mentioned point westwards along the edge of Batticaloa Lake to the western boundary of New Boundary Road.

West : By a line drawn from the last mentioned point north-eastwards along the western boundary of New Boundary Road to the starting point of the northern limit of the Ward.

Ward No. 14

North : By a line drawn from the point of intersection of the western boundary of New Boundary Road and the edge of Batticaloa Lake south-eastwards along the said edge to the northern extremity of the western limit of Ward No. 8.

East : By a line drawn from the last mentioned point southwards along the western limit of Ward No. 8 to the eastern extremity of the northern limit of Ward No. 12.

South : By a line drawn from the last mentioned point north-westwards along the northern limit of Ward No. 12 and Ward No. 13 to the western boundary of New Boundary Road.

West : By a line drawn from the last mentioned point north-eastwards along the western boundary of New Boundary Road and along its prolongation crossing Bar Road to the starting point of the northern limit of the Ward.

Ward No. 15

North and East : By a line drawn eastwards and south-eastwards along the Low Water Mark of the sea to the eastward prolongation of the centre line of Kallady Pillaiyar Kovil Soa Beach Road.

South : By a line drawn from the last mentioned point westwards along the said prolongation and the centre line of Kallady Pillaiyar Kovil Soa Beach Road to the centre line of Batticaloa-Kalmunai Road; thence northwards along the centre line of the latter mentioned road to the centre of its junction with Mariamman Kovil Road; thence westwards along the centre line of the said road to the edge of Batticaloa Lake.

West : By a line drawn from the last mentioned point northwards, north-westwards and westwards along the edge of Batticaloa Lake to the starting point of the northern limit of the Ward.

Ward No. 16

North : By a line drawn from the western extremity of the southern limit of Ward No. 15 eastwards, southwards and again eastwards along the southern limit of the said ward to its eastern extremity.

East : By a line drawn from the last mentioned point south-eastwards along the Low Water Mark of the Sea to the eastward prolongation of the centre line of Puncchimmiai Lane.

South : By a line drawn from the last mentioned point eastwards along the said prolongation and the said centre line to the centre line of Batticaloa-Kalmunai Road; thence northwards along the centre line of the said road to the centre of its junction with Murugapper Lane; thence eastwards along the centre line of the said lane to the edge of Batticaloa Lake.

West : By a line drawn from the last mentioned point northwards along the edge of Batticaloa Lake to the starting point of the northern limit of the Ward.

Ward No. 17

North : By a line drawn from the western extremity of the southern limit of Ward No. 16 eastwards, southwards and again eastwards along the said southern limit to its eastern extremity.

East : By a line drawn from the last mentioned point south-eastwards along the Low Water Mark of the Sea to the eastward prolongation of the centre line of Cemetery Road.

South : By a line drawn from the last mentioned point eastwards along the said prolongation and the said centre line to the centre line of Mather Road; thence eastwards along the centre line of Mather Road to the edge of Batticaloa Lake.

West : By a line drawn from the last mentioned point north-westwards along the edge of Batticaloa Lake to the starting point of the northern limit of the Ward.

Ward No. 18

North : By a line drawn from the western extremity of the southern limit of Ward No. 17 eastwards along the said limit to its eastern extremity.

East : By a line drawn from the last mentioned point south-eastwards along the Low Water Mark of the Sea to the eastward prolongation of the centre line of Colony Road.

South : By a line drawn from the last mentioned point eastwards along the said prolongation and said centre line to the centre line of Manchantuduwai Temple Road; thence eastwards along the centre line of the said road to the edge of Batticaloa Lake.

West : By a line drawn from the last mentioned point north-westwards along the edge of Batticaloa Lake to the starting point of the northern limit of the Ward.

Ward No. 19

North : By a line drawn from the western extremity of the southern limit of ward No. 18 eastwards along the said limit to its eastern extremity.

East : By a line drawn from the last mentioned point south-eastwards along the Low Water Mark of the Sea to the eastward prolongation of the southern boundary of Boundary Lane.

South : By a line drawn from the last mentioned point westwards along the said prolongation and the said southern boundary to the eastern boundary of Batticaloa-Kalmunai Road; thence south-eastwards along the said eastern boundary to the eastward prolongation of the southern boundary of Kattankudi Boundary Road; thence westwards along the said prolongation and the said southern boundary to the edge of Batticaloa Lake.

West : By a line drawn from the last mentioned point north-westwards along the edge of Batticaloa Lake to the starting point of the northern limit of the Ward.
