## **NOTICES UNDER THE WASTE LANDS ORDINANCES.**

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 6th day of November, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Galle Kachcheri and make claim to the said land or to some interest therein : I, Herbert Wace, Government Agent of the Southern Province, in pursuance of the powers invested by Ordinances No. 1 of 1897 and No 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

*Description of Land referred to.*

The land called Polattukanda, situate in the village Kosgoda of the Bentota-Walallawiti korale in the Galle District of the Southern Province, containing in extent 519 acres, as described in the annexed plan, and bounded as follows: on the north by minor road from Kosgoda to Elpitiya, lands described in title plans Nos. 87,474, 87,475, 114,227, 114,226, and 111,089; on the south by land described in title plan No. 168,156; on the east by lands described in title plans Nos. 87,255, 85,221, 85,226, 85,227, 85,225, 87,498, 111,090, 47,494, 87,495, 85,243, 114,235, 87,492, 87,488, 85,237, and 87,487; and on the west by lands described in title plans Nos. 87,473, 53,157, 87,479, 87,476, 87,477, 87,478, 84,480, 87,484, 53,155, 147,901, 147,909, and 149,758.


