NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 28th day of October, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein :

I, Bertram Hill, Assistant Government Agent of the Kegalla District, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

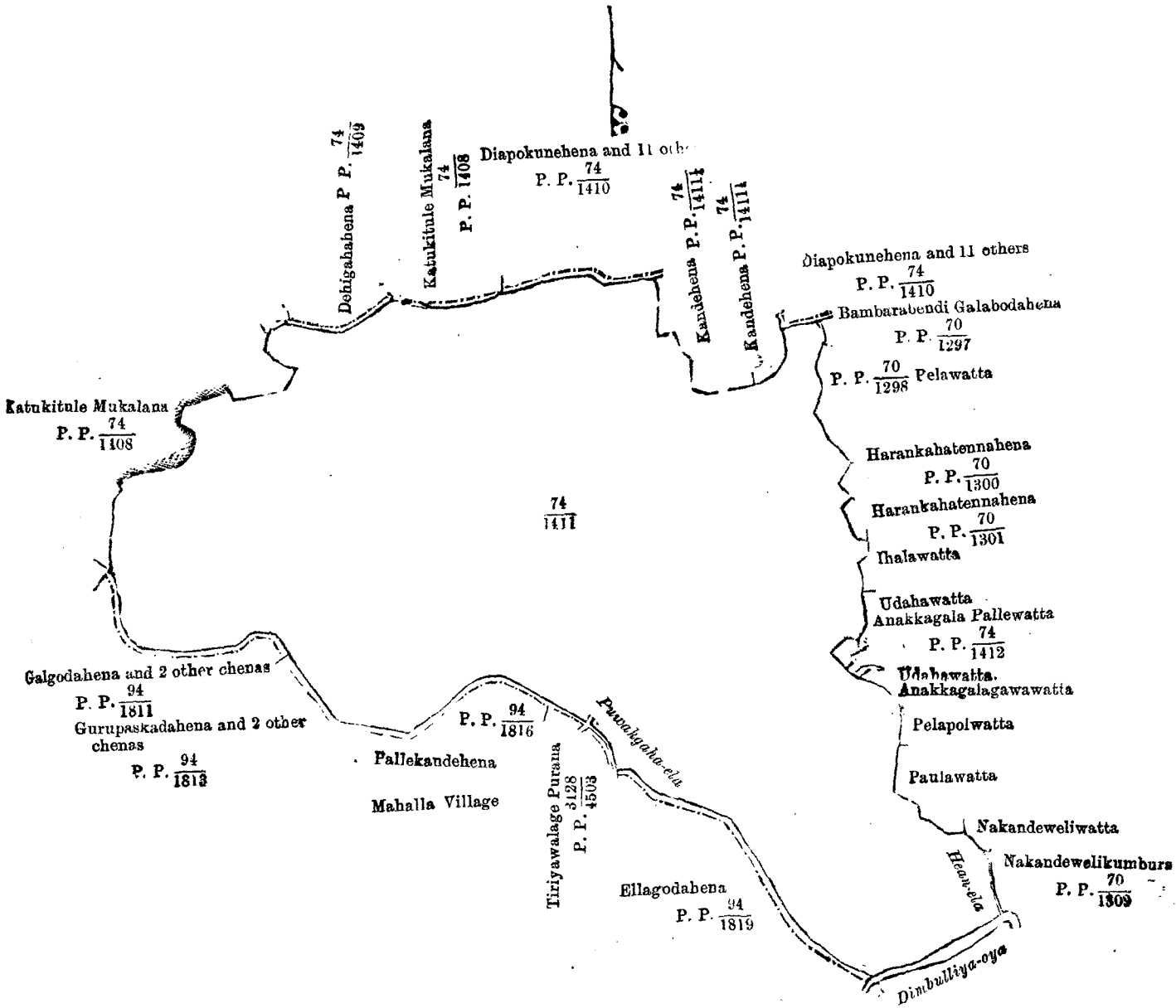

Description of Land referred to.

Lot 1,411 in preliminary plan No. 74 comprising the lands called Weralutennahena, Galaudahena, Maditiyahena, Talpeddewawuluhena, Niyagammalahena, Polgahahena, Mukalanagala, Kiriwelahena, Koboelahena, Minnanwelihena, Korawakahena, Nakandewelihena, Annakkagalaudahena, Alakotuwahena, Weralutennahena, Mawatehena, Weralutennahena, Patheriyahena, and Dikgalpotta, situate in the village of Humbaswalana in Dehigampal korale of Three korales, in the Kegalla District, containing in extent 318 acres 3 roods and 33 perches, as described in the annexed plan, and bounded as follows: on the north by Dehigahahena (preliminary plan 74/1,409) claimed by Dewale Haluwa and two others, Katukitule-mukalana (preliminary plan 74/1,408), Diyapokunehena and eleven other chenas (preliminary plan 74/1,410) claimed by Diwala Undiya and two others, Kandehena (preliminary plan 74/1,411 1/4), Kandehena (preliminary plan 74/1,411 1/2), Diyapokunehena and eleven other chenas (preliminary plan 74/1,410) claimed by Dewale Undiya and two others; on the east and south-east by Bambarabendigalabodahena (preliminary plan 70/1,297) claimed Wahumpuraya and others, Pelawatta (preliminary plan 70/1,298), Wahumpuraya and others, Harankahatennahena (preliminary plan 70/1,300) claimed by Ellawalage Subaya and two others Harankahatennahena (preliminary plan 70/1,301) claimed by Ambagalage Kalinga and another, Ihalawatta, Udahawatta, Annakkagalapallewatta (preliminary plan 74/1,412) claimed by Ellawalage Undiya and another, Udahawatta, Annakkagalagawawatta, Pelapolwatta, Paulawatta, Nakandewelawatta, Nakandewelakumbura (preliminary plan 70/1,309), and Dimbulliya-oya; on the south and south-west by the village boundary of Mahalla; on the west by Katukitulamukalana (preliminary plan 74/1,408).
