NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the Sixth day of December, 1899, the persons, if any, who claim any interest in the land herein-after mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein :


