SALES OF ARRACK, TOLL, AND OTHER RENTS.

In accordance with the requirements of section 8 of "The Opium Ordinance, 1899," I hereby give notice that the license for the sale by retail of opium within the limits of the Board of Improvement, town of Nuwara Eliya, for the year commencing January 1, 1900, will be one in number.

The said license will be put up for sale by public auction at the Assistant Government Agent's Office at Nuwara Eliya at noon on Monday, December 4, 1899, and will be issued in accordance with the provisions of the aforesaid Ordinance, and under the following conditions:—

Conditions.

1. No opium shall be sold between the hours of 8 at night and 6 in the morning.
2. The quantity to be sold at any one time to any individual, except to a licensed retail vendor, shall not exceed 180 grains.
3. Opium shall not be consumed on the premises.
4. Opium offered for sale shall not be adulterated or deteriorated in any way.
5. Opium shall not be sold to any individual apparently under the age of 15 years, to any woman, or to any intoxicated person.
6. Wearing apparel or other goods shall not be received in barter for opium.
7. Daily accounts shall be kept in a form which will be prescribed by the Assistant Government Agent of Nuwara Eliya of the quantities of opium received, sold, and remaining on hand at the end of each day.
8. The place licensed shall be always kept clean.
9. The licensee shall affix in some conspicuous part of his shop a board with his name, the number of the shop, and the words "Licensed to Sell Opium by Retail" painted on it.

10. No person other than the licensee shall sell or expose for sale any opium under his license, either as agents or servants of the licensee, unless the name of such agents or servants be first registered in the Board of Improvement Office.

In terms of section 8 of Ordinance No. 5 of 1899, notice is hereby given that the right to sell opium by retail at Dikwella, Matara, at a place to be approved by me, will be put up for sale by public auction for a period of 12 months commencing from January 1, 1900, at the Matara Kachcheri on Thursday, December 7, 1899, at 2 o'clock P.M., and the license will be issued in accordance with the provisions of the said Ordinance.

The following are conditions of sale:—

1. That no opium shall be sold between 8 P.M. and 6 A.M.
2. That the place licensed shall be subject to inspection, and that no disorderly conduct be permitted therein.
3. That the place licensed be always kept clean.
4. That opium shall not be possessed at one time in any quantity exceeding 50 lb.
5. That the quantity to be sold at any one time to any individual, except to a licensed retail vendor, shall not exceed 180 grains.
6. That opium shall not be sold for consumption at the vendor's premises, but shall be taken by the buyers and receivers and consumed elsewhere.
7. That opium shall not be sold to any person apparently under the age of 15 years.

 11. No wholesale license will be issued to any but the retail dealer.

ව්‍යාපෘති 1900 ක්‍රු ජයවාරි මස 1 වෙනි දින පැවත්වූ ව්‍යාපෘති 1910 ක්‍රු දෙසැම්බර් මස 31 වෙනි දින දක්වා යාපනේ දියත්තික්ෂණවල ක්‍රුවට වඩා මැයිම් ඇතුළුය ඇවා රිකරිඹ වියින්ස්ට්ට එක අවසරපත්‍රයක් දෙනු ලබව ව්‍යාපෘති 1899 නේ 5 වෙනි ආයුර්පත්‍රයන් 8 වෙනි වගක්ත්‍යාව එකට මෙයින් දක්වනු ලැබේ. ඒ අවසරය ව්‍යාපෘති 1899 ක්‍රු දෙසැම්බර් මස 2 වෙනි දිනදී සෙකුරුරි ද්‍රව්‍යල් 12 යාපනේ ක්‍රිවලටියේදී ප්‍රක්ෂිඛ වෙත් ගෙස්සියේ එක්කුණුව හෙදෙන්වා ඇත. ඒ අවසරය දෙනු ලේ ඉහළයා ආයුර්පත්‍රයන් නියෝගවල ප්‍රකාරයවද, මෙන් පහත දක්වනු ලබයි—

 4. ටික ටික විකුණෙන්ට අවසර ලබාගත් කොහො කුට මිස වෙන කිසියම් කොහොතුව එක වරට විකුණෙන ප්‍රමාණය යුරෙන් 180ට වැඩිවෙන්ට පුතු තැබ.
 5. අඩි. එවා විකුණෙන ඉඩුමේද පාමිලිකරීම පුතු තැබ.
 6. විකුණෙන්ට තීබෙන අඩි. කොඩි අනුදලිකිවන්ට වෙන දුවතාකා සාම්ඛ මිශ්‍රකරන්ට වත් කරක්කරන්ට වත් පුතු තැබ.
 7. අවුරුදු 15ට අමු වයස් ඇති කොහො වගේ දෙනෙකුන් කොහොතුව අඩි. විකුණීම පුතු තැබ.

11. නොවේද විනිශ්චිතව අවසරයක් එක වික විභාගෙහි තෙකුනුව මිනින්දෝ සෙනු කෙටෙනුවට මිනින්දෝ වෙත කෙටෙනුවට දෙන්නේ තැබූ.

பொருத்தங்களாவன.

1. இரா எட்டு மணிக்குப் பின்னும் காலமே ஆறு மணிக்கு முன்னும் அபின் விற்கக்கூடாது.

2. சில்லறை விற்பனைக்குத் தத்துவம்பெற்றவருக்கால்லாது மற்ற எவருக்கும் ஒரே சமயத்தில் 180 கிரே மிலுக்கு அதிகப்பட விற்கக்கூடாது.

3. அபின் விற்கு மிடத்தில்தானே அபின் சாப்பிடக் கூடாது.

4. விலைக்குவத்திருக்கும் அபின் கலப்புச்செய்வ தினால் அல்லது வேறு எவ்விதமாயாகுதல் அச்டாக்கக் கூடாது.

5. பார்லைக்கு 15 வயதுக்குக் கீழ்ப்பட்டவருக்கு அபின் விற்கக்கூடாது.

6. உடுக்கும் உடுப்புக்கு அல்லது வேறு ஏதும் சா மானுக்கு அபின் மாற்றக்கூடாது.

7. சரியான தத்துவமுடையவரால் சாட்டப்படும் பிரகாரம் நாள்தோறும் அபின் எவ்வளவு வாங்கப்பட்ட தென்றும், எவ்வளவு விற்கப்பட்டதென்றும், ஒவ்வொரு நாள் முடிவில் எவ்வளவு கையிருப்பென்றும் கணக்கு கைக்கவேண்டும்.

8. தத்துவம்பெற்றவன் தனது சாய்ப்பில் ஒரு வெளியரக்கமான இடத்தில் தனது பெயரையும், சாய்ப்பின் இலக்கத்தையும் “அபின் சில்லறையாய் விற்பதற்குத் தத்துவம் பெற்றது” என்பதையும் ஒரு பலகையில் எழுதி தொக்கவேண்டும்.

9. தத்துவம் பெற்றஆள் அல்லாமல் வேறே ஒருவரும் அவனுடைய காரியகாரனுயிருந்தாலும் சரி அல்லது வேலைகாரனுயிருந்தாலும் சரி அப்படிப்பட்ட வேலைகாரன் அல்லது காரியகாரன் யாழ்ப்பாணக் கச்சேரி யில் சுண்டருடைய அனுமதிப்படி பதியப்பட்டால்லலாமல் யாதாமொரு அபின் அவனுடைய உத்தரவுண் கீழ் விற்க அல்லது விற்கும்படி வைத்திருக்கக்கூடாது.
