Food Price Order No. C. 462

#### THE CONTROL OF PRICES ACT

#### ) rdo

BY virtue of the powers vested in the Controller of Prices (Food), by section 4 of the Control of Prices Act (Chapter 173), I, Buhanakabahu Piyange Victor Alexander Justin Purnavansa Senaratne, Controller of Prices (Food), do by this Order —

- (i) revoke with immediate effect Food Price Order No. C. 460 dated February 22, 1969, published in the Ceylon Government Gazette Extraordinary No. 14,842/2 of February 22, 1969;
- (ii) fix with immediate effect the prices specified in columns 2,3 and 4 of the Schedule hereto to be an Importer's maximum wholesale price per cwt. gross, a wholesale dealer's maximum wholesale price per hundred-weight gross and a retail dealer's maximum retail price per pound nett to a consumer, respectively, above which the articles specified in the corresponding entry in column 1 of the Schedule shall not be sold within the Municipal Limits of the town of Colombo;
- (iii) direct that for the purpose of this Order-
  - (a) any sale of any quantity of an article specified in column 1 of the Schedule for the purpose of re-sale, or any sale of an article specified in column 1 of the Schedule in a quantity of one hundred-weight gross or more at a time shall be deemed to be a sale by wholesale;
  - (b) any sale of any quantity of an article specified in column 1 of the Schedule, less than one hundred-weight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
- (iv) direct that in every area where maximum prices are fixed by this Order, no person shall sell any article specified in column 1 of the Schedule which is adulterated with any other article;
- (v) direct that in every area where maximum prices are fixed by this Order, every trader, who has any article specified in column 1 of the Schedule in his possession or under his control at any place or in any vehicle, shall exhibit conspicuously at that place or on that vehicle a quantity of such article in a suitable container, with the maximum prices for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the article and the maximum prices could be clearly seen by any customer;
- (vi) direct that for the purpose of this Order, "pound" or "lb." shall be deemed to be the standard pound avoirdupois weight;
- vii) direct that in every area where maximum prices are fixed by this Order, every person who sells any article specified in column 1 of the Schedule by wholesale shall, and every person who sells any articles specified in column 1 of the Schedule by retail shall, on demand, give the purchaser thereof, a receipt in which there shall be set out—
  - (a) the date of the sale;
  - b) the quantity of such articles sold (by weight);
  - (c) the price paid for the quantity sold;
  - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or by retail;

#### THE CONTROL OF PRICES ACT

#### Orde

BY virtue of the powers vested in me by section 4, read with section 3 (2) of the Control of Prices Act (Chapter 173) I, Charles Abeydeera, Assistant Controller of Prices (Food), for Galle District, do by this Order—

- (i) revoke with immediate effect the Food Price Order No. G 5 of 1968 dated September 12th, 1968, published in Gazette Extraordinary No. 14,819/6 of September 17th, 1968;
- (ii) fix with immediate effect the price for the time being fixed under the Control of Prices Act (Chapter 173) as the whole sale dealer's maximum wholesale price for Colombo Municipality, increased by amounts specified in column 3 of the Schedule hereto, to be the maximum wholesale price per hundredweight gross above which the article specified in the corresponding entry in column 1 of that Schedule shall not be sold within the area or the administrative district specified in column 2 of that Schedule;
- (iii) fix with immediate effect the price for the time being fixed under the Control of Prices Act (Chapter 173), as the retail dealer's maximum retail price for the Colombo Municipality, increased by the amounts specified in coulmn 4 of the Schedule hereto, to be the maximum retail price per pound nett above which the article specified in the corresponding entry in column 1 of that Schedule shall not be sold within the area or the administrative district specified in column 2 of that Schedule;
- (iv) direct that for the purpose of this Order-
  - (a) any sale of any quantity of an article specified in column 1 of the Schedule hereto, for the purpose of re-sale or any sale of an article specified in column 1 of that Schedule in a quantity of one hundred weight gross or more at a time shall be a sale by wholesale;
  - (b) any sale of any quantity of an article specified in column 1 of the Schedule hereto, less than one hundredweight gross for the purpose of consumption or use shall be deemed to be a sale by retail;
- (v) direct that in every area where maximum prices are fixed by this Order, no person shall sell any article specified in column 1 of the Schedule hereto, which is adulterated with any other article;
- (vi) direct that in every area where maximum prices are fixed by this Order, every trader, who has any article specified in column 1 of the Schedule hereto, in his possession or under his control, at any place or in any vehicle, shall exhibit conspicuously at such place or in such vehicle a quantity of such article in a suitable container with the maximum price for such article fixed by this Order displayed in figures not less than one inch in height on price tags or boards attached to such container in such a manner that the article and the maximum price thereof could be clearly seen by any customer;
- (vii) direct that for the purpose of this Order "Pound" or "lb." shall be deemed to be the standard pound avoirdupois weight;
- (viii) direct that in every area where maximum prices are fixed by this Order, every person, who sells any article specified in column 1 of the Schedule hereto by wholesale shall, and every person who sells any article specified in column 1 of that Schedule by retail shall, on demand, give the purchaser thereof a receipt in which there shall be set out—
  - (a) the date of the sale;
  - (b) the quantity of such articles sold (by weight);
  - (c) the price paid for the quantity sold; and
  - (d) the nature of the transaction, that is to say, whether the sale was by wholesale or retail;
- (ix) direct that when any article specified in column 1 of the Schedule hereto is sold, the maximum price referred to in solumns 3 and 4 of that schedule shall include the price of the wrapper or container, if any, in which such article is sold.
