Applications for inspection will, however, be accepted up to 3 p. m. on working days and 12 noon on half days.

##### Trade Marks limited to Colours

Where it is stated in the advertisement of an application that the mark upon its registration is to be limited to

certain colour the colours are, as far as possible, indicated in the accompanying representation of the mark in the usual heraldic manner

##### Association

Where it is stated that an advertised mark is to be associated with Section 22 of the Trade Marks Ordinance (Cap. 121) another mark, it is indicated by its official number.

##### Application in Part A or Part B

Applications for registration in Part A of the Register are shown the official number unaccompanied by any letter. Applications for Part B of the register are distinguished by the letter B prefixed to the official number.

#### OPPOSITION

NOTICE is hereby given that any person who has grounds of objection to registration of the following trade marks may, within two months from the date of this Gazette, lodge Notice of Opposition on form T.M. No. 7 bearing an uncancelled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and upon such terms as he may direct.

Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant or registration as to afford him an opportunity of withdrawing his application before the expenses of preparing the Notice of Opposition are incurred. Failure to give such notice will be taken into account in considering any application by an opponent for an Order of Costs if the opposition is uncontested by Applicant.

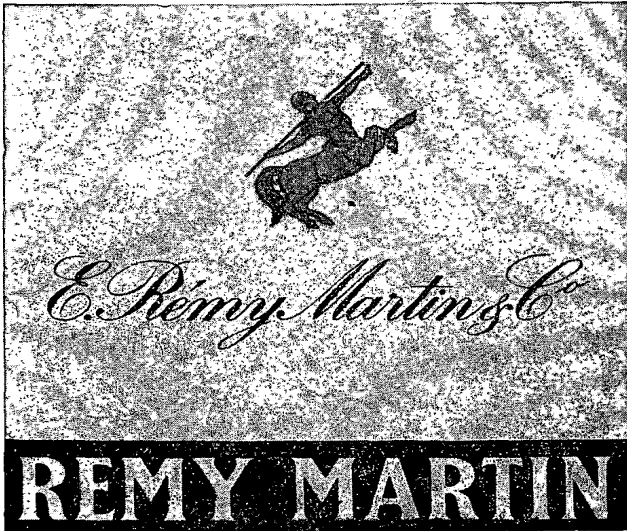

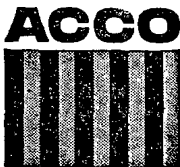

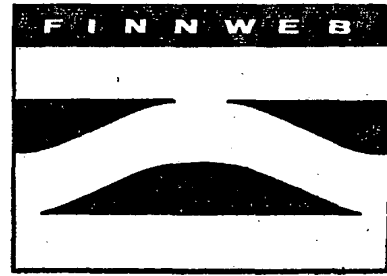

THE Weekly issue of the *Ceylon Government Gazette* is normally published on Fridays. If a Friday happens to be a Public Holiday the *Gazette* is published on the working day immediately preceding the Friday. Thus the last date specified for the receipt of notices for publication in the *Gazette* also varies depending on the incidence of public holidays in the week concerned.

The Schedule below shows the dates of publication and the latest time by which notices should be received for publication in the respective weekly *Gazettes*. All notices received out of times specified below will not be published. Such notices will be returned to the sender by post for necessary amendment and return if publication is desired in a subsequent issue of the *Gazette*. It will be in the interest of all concerned if those desirous of ensuring the timely publication of notices in the *Gazette* make it a point to see that sufficient time is allowed for postal transmission of notices to the Government Press.
