Hours of Inspection

The office shall be open to the public on every working day between the hours ten to four, and on every half day between the hours ten to one.

Applications for inspection will, however, be accepted up to 3 p.m. on working days and 12 noon on half days.

OPPOSITION

NOTICE is hereby given that any person who has grounds of objection to the registration of the following trade marks may, within two months from the date of this Gazette, lodge Notice of Opposition on form T.M. No. 7 bearing an uncancelled or impressed stamp of Rs. 25. The period of lodging Notice of Opposition may be enlarged by the Registrar if he thinks fit and upon such terms as he may direct.

Formal opposition should not be lodged until after reasonable notice has been given by letter to the Applicant for registration as to afford him an opportunity of withdrawing his application before the expenses of preparing the Notice of Opposition are incurred. Failure to give such notice will be taken into account in considering any application by an opponent for an Order of Costs if the opposition is uncontested by the Applicant.
