THE IMPORT AND EXPORT (CONTROL) ACT, NO. 1 OF 1969

REGULATIONS made by the Minister of State under Sections 4(3), 14 and 20 of the Imports and Exports (Control) Act, No. 1 of 1969.

Regulations

1. The Import Licensing (Special Provisions) Regulations, 1969, published in *Gazette Extraordinary* No. 14,866/2 of August 9, 1969, are hereby amended in the Schedule thereto by the substitution for the word "Department" in paragraph 1 thereof, of the word "Controller".

2. The Import (Exemption) Regulations, 1969, prulished in *Gazette Extraordinary* No. 14,866/2 of August 9, 1969, are hereby amended in regulation 2 thereof, by the substitution, for paragraph (3) thereof, of the following new paragraph :----

- "(3) Trade samples sent free by trading establishments abroad to their local agents, if-
 - (a) such trade samples are of such goods as are allowed to be imported under Open General Licences or Trade Quota Licences,
 - (b) the c.i.f. value of any single consignment of such trade samples, other than of trade samples of drugs, does not exceed Rs. 1,000, and

(c) such trade samples are not imported in commercial quantities or for sale".
