THE EXCHANGE CONTROL ACT

BY virtue of the powers vested in me by section 4 of the Exchange Control Act (Chapter 423), I, Ukku Banda Wanninayake, Minister of Finance, do hereby—

- (1) amend with effect from November 1, 1969, the authorisation under the said section published in Gazette No. 10593 October 2, 1953, in the First Schedule thereto, by the omission of the item relating to the Eastern Bank Ltd., Colombo and
- (2) authorise the Commercial Bank of Ceylon Ltd., to act for the purposes of the said Act as an Authorised Dealer, in relation to all foreign currencies, with effect from November 1, 1969, subject to the condition that for the purposes of conserving exchange and giving effect to the principles of the said Act, the said Bank shall conduct its business in accordance with such directions as the Controller of Exchange may give in writing.
