IT is hereby notified for the purpose of the application of the Order under Section 2 of the Revenue Protection Act, No. 19 of 1962 published in *Gazette Extraordinary* No. 14,775/17 of 22nd November, 1967, and ratified by the House of Representatives on 22.2.68 that the estimated c.i.f. price of Philippines copra in the London Market for the week commencing on Monday, the 17th November, 1969, is Rs. 1,289.33.
