Tenders to be considered must be in this form (without any alterations or additions) and enclosed in a sealed envelope marked with the above-mentioned tender number for Newsprint and must be submitted in triplicate and sent by Registered Post addressed to the Permanent Secretary, Ministry of State, 54, Chatham Street, Colombo 1, Ceylon, and be received there by him not later than 9.30 a.m. on 17th December, 1969.

Enquiries before tendering should be marked with the above-mentioned tender number and addressed to the Office of the High Commissioner for Ceylon, The Sandringham, Suites 103 and 104, 85, Range Road, Ottawa 2, Ontario.

At the same time as your tender is despatched to the Permanent Secretary, Ministry of State, Colombo, Ceylon, a copy must be sent in a double envelope, with the inner envelope marked "Tender—Ceylon Newsprint", to the Canadian International Development Agency, 75, Albert Street, Ottawa, Ontario, accompanied by a completed declaration of Canadian content form. The copy of the tender received by the Canadian International Development Agency will be treated as a sealed tender and will not be opened until the prescribed opening date.

Joint or group tenders will not be considered. The Permanent Secretary may reject the lowest or any tender without assigning any reason therefor.

All prices shall be stated in Canadian Dollars F.A.S. Canadian seaport including terminal charges.

Payment of F.A.S. costs is to be made by the Canadian International Development Agency under the terms of a Canadian Commodity Loan Agreement.

Note re Delivery :--

Initial deliveries must be considered urgent and suppliers are requested to state earliest possible delivery schedules for each item.

Time shall be deemed to be of the essence of the contract provided that the time for completing any of the work which has been or is likely to be delayed by reason of force majoure or other cause beyond the reasonable control of the Contractor shall be extended by a period equal to the length of the delay so caused, provided that prompt notice in writing of the occurrence causing or likely to cause such delay is given to the Permanent Secretary, Ministry of State, Colombo, Ceylon.

The contractor shall not assign the contract or sublet any of the work without the prior written consent of the Permanent Secretary, Ministry of State, Colombo, Ceylon.

Packing:-

To be carried out in accordance with highest commercial standards for export shipment by sea with adequate waterproofing and protection.

Warranty:-

Manufacturer warrants that the supplies shall be free from any defects in material or workmanship.

Inspection :--

Inspection will be arranged to the mutual satisfaction of the supplier and the purchaser at a time prior to shipment from the suppliers plant and the supplier shall give the purchaser due notice when and where the supplies will be available for inspection.
