#### THE ASSISTED SCHOOLS AND TRAINING COLLEGES (SUPPLEMENTARY PROVISIONS) ACT No. 8 OF 1961

Order under section 10

#### G/GANEGAMA BUDDHIST MIXED SCHOOL, BADDEGAMA

BY virtue of the powers vested in me by section 10 of the Assisted Schools and Training Colleges (Supplementary Provisions) Act, No. 8 of 1961, I, Imiya Mudiyanseelage Raphael Abhayawansa Iriyagolle, Minister of Education and Cultural Affairs, do by this order revoke with effect from the 1st day of January, 1970, the Vesting Order No. 1457 published in *Gazette Extraordinary* No. 13.169 of June 15, 1962, save and except the property specified in the Schedule hereto.

#### SCHEDULE

1. The premises in which G/Ganegama Buddhist Mixed School, Baddagama was conducted and maintained on July 21, 1960, viz: all that portion from and out of the land called and known as Weliliadde, situated in Ganegama South of Galu Gangaboda pattu of the District of Galle, Southern Province and which portion is bounded on the—

North by: Udumulla Watta, (portion of) Sandarawala and the land belonging to H. L. Samuel bearing plan No. 1059A containing in extent 14.625 perches.

East by: Udumulla Watta, Wanduramba-Baddagama Public Road and the aforesaid land belonging to H. L. Samuel bearing plan No. 1059A and a portion of Weliliyadda Watta.

South by: the aforesaid land belonging to H. L. Samuel bearing plan No. 1059A and a portion of Weliliyadda Watta,

West by: a portion of Sandarawala, Weligodella and a portion of Weliliyaddawatta, and containing in extent about two roods (2A. 2R. 0P.).

2. All the buildings and structures in or on the land specified in paragraph 1 of this Schedule.

3. All movable property used for the conduct and maintenance of the said school as declared in the National Educational Survey Forms and the inventories and records maintained in and on behalf of the said school.

4. All moneys lying to the credit of the said school due to it by way of grants from the Director of Education and all other grants, fees, donations and endowments held for and on behalf of such school by proprietor or by any other person or persons.

Vesting Order No. 2610

#### C/ST. JOHN BOSCO'S COLLEGE, KALUAGGALA, HANWELLA

BY virtue of the powers vested in me by Section 4 of the Assisted Schools and Training Colleges (Supplementary Provisions) Act, No. 8 of 1961, I, Imiya Mudiyanseelage Raphael Abhayawansa Iriyagolle, Minister of Education and Cultural Affairs, do hereby declare, that with effect from the 1st day of January, 1970, all property specified in the Schedule appended hereto, being property liable to vesting shall vest in the Crown.

#### SCHEDULE

1. Block A.—The premises in which the Handicraft and Scout Room of C/St. John Bosco's College, Kaluaggala, was conducted and maintained on 1.1.1968, viz., all that land bounded on the North by land vested for C/Kaluaggala R. C. School by Vesting Order No. 2028, on the East by a straight line parallel to the Eastern wall of the said Handicraft room at a distance of 12 feet from the said wall and the base of the mount on which the Church Calvary stands, on the South by the base of the mount of on which the said Church Calvary stands and by a straight line 18 feet long parallel to the Southern most wall of the said Handicraft and Scout Room at a distance of 5 feet from the said wall of the Handicraft and Scout Room and on the West by Crown land about 6 perches in extent situated in Kaluaggala in Hewagam Korale East in the District of Colombo of the Western Province.

**Block B.**—The premises in which C/St. John Bosco's College, Kaluaggala was conducted and maintained on 1.1.1968, viz., all that land bounded on the North by a straight line, parallel to the Southern most wall of the Kaluaggala St. John Bosco's Church 70 feet long commencing from the point 10 feet South of the South West corner of the said Church building and from there by a straight line stretching in a North Easterly direction upto the boundary of the property already vested in the Crown for C/Kaluaggala R. C. School by Vesting Order No. 2028 and the property vested for the said R. C. School and the land known as Ambagahawatta, on the East by Ambagahawatta, South by a playground of St. John Bosco's College (to be vested as Block C) and on the West by a straight line stretching Northwards from the point 10 feet West of the Westernmost flight of steps leading to the pavilion and the playground upto the point 10 feet South of the South West corner of the said Church building about 90 perches in extent situated in Kaluaggala in Hewagam Korale East in the District of Colombo, Western Province.

**Block C.**—The playground of C/St. John Bosco's College, Kaluaggala, used and maintained on 1.1.1968, viz. all that land bounded on the North by the property vested as Block B above and land known as Ambagahawatta and Helandawatta *alias* Helanda Landa, East by Helandawatta *alias* Helands Landa, South by the same Helandawatta *alias* Helanda Landa and on the West by Kaluaggala Labugama P.W.D. Road in extent about 2 acres, situated in Kaluaggala in Hewagam Korale East in the District of Colombo of Western Province.

With right of foot access as well as right of way for vehicular traffic to Blocks A, B and C from the main entrance to the Church premises from the embankment of the playground of St. John Bosco's College, Kaluaggala, commencing from the P.W.D. Road from Kaluaggala to Labugama and Colombo-Avissawella P.W.D. Road along the present road to the Church and from beyond the Church between the Church and the Mission House.

**Block D.**—The premises in which the bungalow of the Principal of St. John Bosco's College situated, viz., all that land bounded on the North by the Colombo-Avissawella P.W.D. Road on the East by Walawwatta on the South by Moonamale *alias* St. Rita's Estate and on the West also by Moonamale *alias* St. Rita's Estate in extent about 80 perches situated at Kaluaggala in Hewagam Korale East in the District of Colombo in Western Province.

2. All the buildings and structure in or on the land specified in paragraphs 1, 2, 3 and 4 viz., Handicrafts and Scout Room in Block A. One two storeyed block comprising Science laboratories and class rooms, one two storeyed block comprising class room, assembly hall and library in Block B.

Terraced open air stage and two storeyed pavilion in Block C and Principal's bungalow and all other structure in Block D.

3. All movable property used for the conduct and maintenance of the said school as declared in the National Educational Survey Forms and the Inventories and Records maintained in and on behalf of the said school.

4. All moneys lying to the credit of the said school due to it by way of grants, from the Director of Education and all other grants, fees, donations, and endowments held for and on behalf of such school by the proprietor or by any other person or persons.
