NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the Sixth day of December, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Land referred to.

Lots 7,451 and F 351 on preliminary plan No. 5,871 called Narangahamademu kalana, situate in the village Wetenna in Walgam pattu of Kinigoda korale, in the Kegalla District, containing in extent 12 acres 2 roods and 8 perches, as described in the annexed plan, and bounded as follows: on the north by Narangahamadewatta claimed by Appuhami and another and Narangahamadewatta claimed by Ranhami and another; on the east by Galpilehena claimed by Appuhami and Crown land called Negollekanda and a rock; on the south by the Crown land called Kolongahamalatenna; on the west by a water-course, Kehelollehena claimed by Ranhami, a water-course, and Talaghamula-aramba claimed by Dingiri Appu and others.


