NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 15th day of December, 1899, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachoheri and make claim to the said land or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

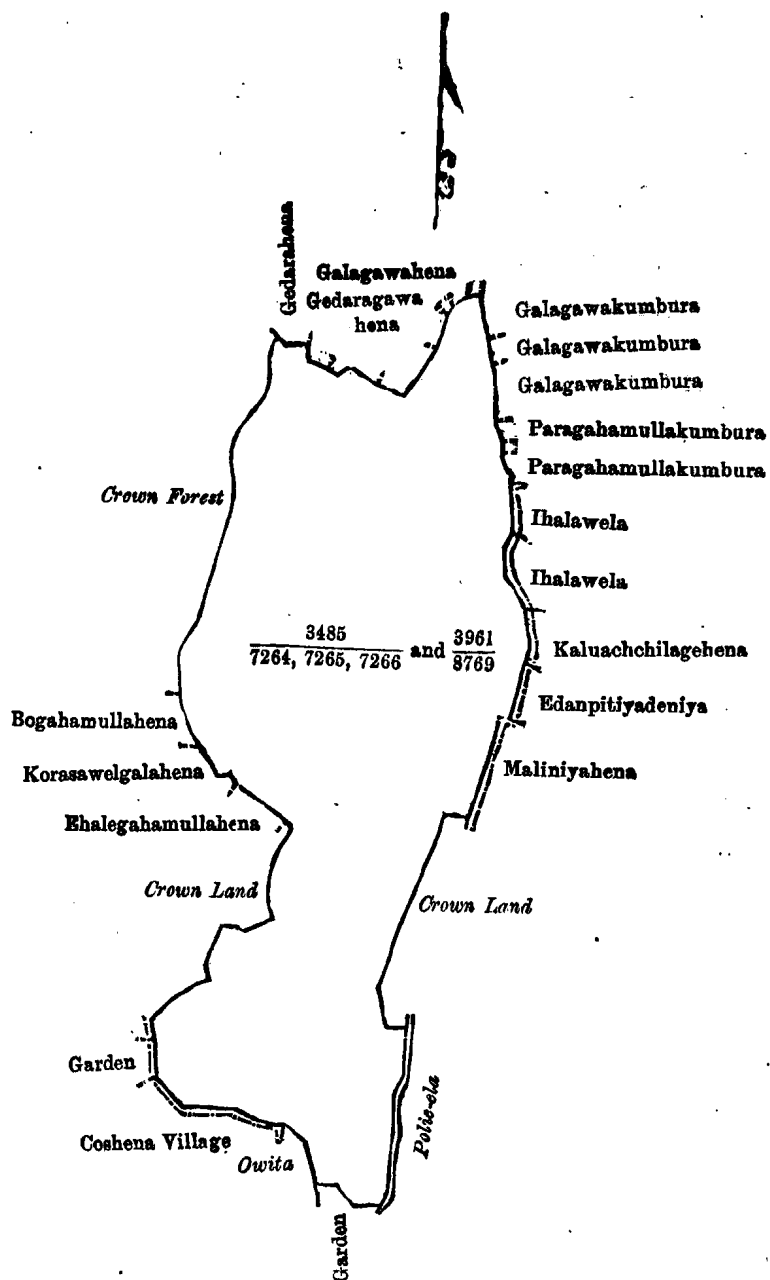

situated in the villages Walalgoda and Kossinna in Meddemedaliya pattu of Kinigoda korale, in the Kegalla District, as described in the annexed plan, and bounded as follows : on the north by Gedarahena claimed by Mudalihami, Gedaragawahena claimed by Appuhami Vel-vidane, Gedaragawahena claimed by the Gan-arachchi, and Galagawahena claimed by Hapuwa ; on the east by Galagawakumbura claimed by Pahalagedara Ranhami, Galagawakumbura claimed by Dabagodilage Appuwa, Galagawakumbura claimed by Sendumalhami, Paragahamullakumbura claimed by Kiri Hapuwa, Paragahamullakumbura claimed by Dingiri Menika, Paragahamullakumbura claimed by Malindurala, Ihalawala claimed by Walalgoda Dingiri Appu, Ihalawala claimed by Walalgoda Punchirala, Kaluachillagehena claimed by Appuhami, Edanpitiyedeniya claimed by Tikiri Menika, Maliniyahena claimed by Walalgoda Unguraja, and the village boundary of Ambatenna, a Crown land, and Palie-ela ; on the south by garden claimed by Dingiri Appu, owita, and the village boundary of Kossinna ; and on the west by garden claimed by Dingiri Appu, a Crown land, Ehelagahamullahena claimed by Punchedi Appuhami, Korasawelgalahena claimed by Kiri Appu, Bogahamullahena claimed by Ukkuhami, and Crown forest.
