NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 22nd day of December, 1899, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at my office at Matara and make claim to the said lands or any of them or to some interest therein :

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

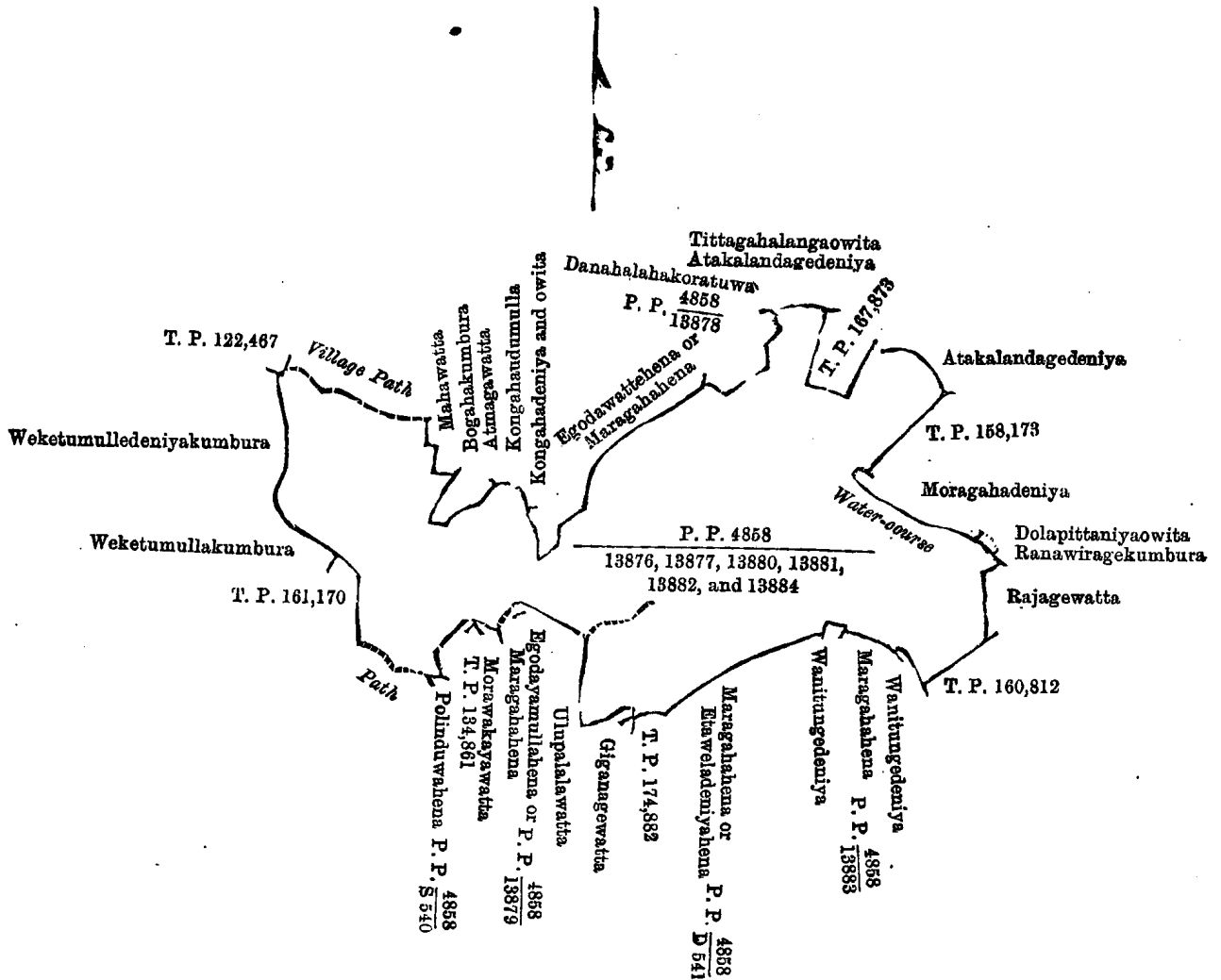
