NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 9th day of February, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The following lots, all situated in the village Utuwana in Tanipperu pattu of Galboda korale, in the Kegalla District, as described in the annexed plan :-

Lot 3,863 on preliminary plan 7,700 called Waduwaluwalumukalana, in extent 12 acres 2 roods and 22 perches ; and bounded on the north by Udapitiya-ela, village boundary of Wetenna village, and Lolunpitiyahena claimed by Pallege Mudalihami ; on the east by village boundary of Gondiwala village, Pansalwatta claimed by Gondiwala Vihare, Boraluwewatta claimed by Boraluwegedara Salinda, Boraluwewatta claimed by Hetigedara Kirimenika ; on the south by an ela (a stream) ; on the west by Boraluwehena claimed by Tampi Kandu, Anthuraullehena claimed by Jambuliagaladge Puchi Appu, Eraminiyagollehena and Wahubeddarahena claimed by Kumbuddiwalage Muhandiram and Hungidige Naide Appu.

Lot 3,865 on preliminary plan 7,700 called Moragolle and Ulumugallehena, in extent 14 acres 1 rood and 15 perches ; and bounded on the north by a portion of Kandawattahena claimed by Hungidige Naide Appu, Hanunagallehena claimed by the Crown, and the village boundary of Wegantale village ; on the east by Andagallehena claimed by Puchi Appu, Dumunuhena claimed by Hungidige Naide Appu, Tibuttahena claimed by Dissawe Hungidige Appu Naide, Damunuhena claimed by Dingiri Naide and Kalumenika ; on the south by Dulgolle or Damunuhena claimed by Baba Uchup Tuwan ; on the west by Henkandegabamulahena claimed by Disawe Hungidige Appu Naide, Dulgollehena claimed by N. P. Puchihami, Dulgollehena claimed by N. P. Puchi Appu, and a portion of Kandawattahena claimed by Hungidige Naide Appu.

Lots 3,867 and 3,868 on preliminary plan 7,700 called Kalahugoda and Polwattahena and Kalahugodamukalana respectively, aggregating in extent 15 acres 3 roods and 14 perches ; and bounded on the north by lot J 890 on preliminary plan 7,700 called Berawedepolakumbura claimed by Amandakon Mudiyanse, and lot K 890 on preliminary plan 7,700 called Kohilakumbura claimed by Wegantala Arachchi ; on the east by Boraluwehena claimed by Hendeniya Korale Banda, Kohilawatta claimed by Welimannalage Ukuwa, Boraluwehena claimed by Welimannalage Janguwa, Boraluwehena claimed by Vedaralage Puchimenika, Boraluwahena claimed by Subalage Salinda, Kongahamulawattahena claimed by Lagame Vidanalage Mudalihami, and the village boundary of Anwarama village ; on the south by Kalahugodamukalana (7,700 / 3,868) claimed by Hendrick Silva Appuhamy, the village boundary of Udattawa Pahalagama village, and Siyambalagahanulawatta claimed by Joseph Fernando ; on the west by Pathangallawatta claimed by Chunchatin Tuwan, Polwattahena claimed by Maddumage Naide, Polwattahena claimed by Jambuliagaladge Puchi Appu, Polwatta claimed by Kumburuwalage Muhandirama, Arambawatta claimed by Kumbuduwalage Muhandirama and another, Arambahena claimed by Jambuliagaladge Puchi Appu.

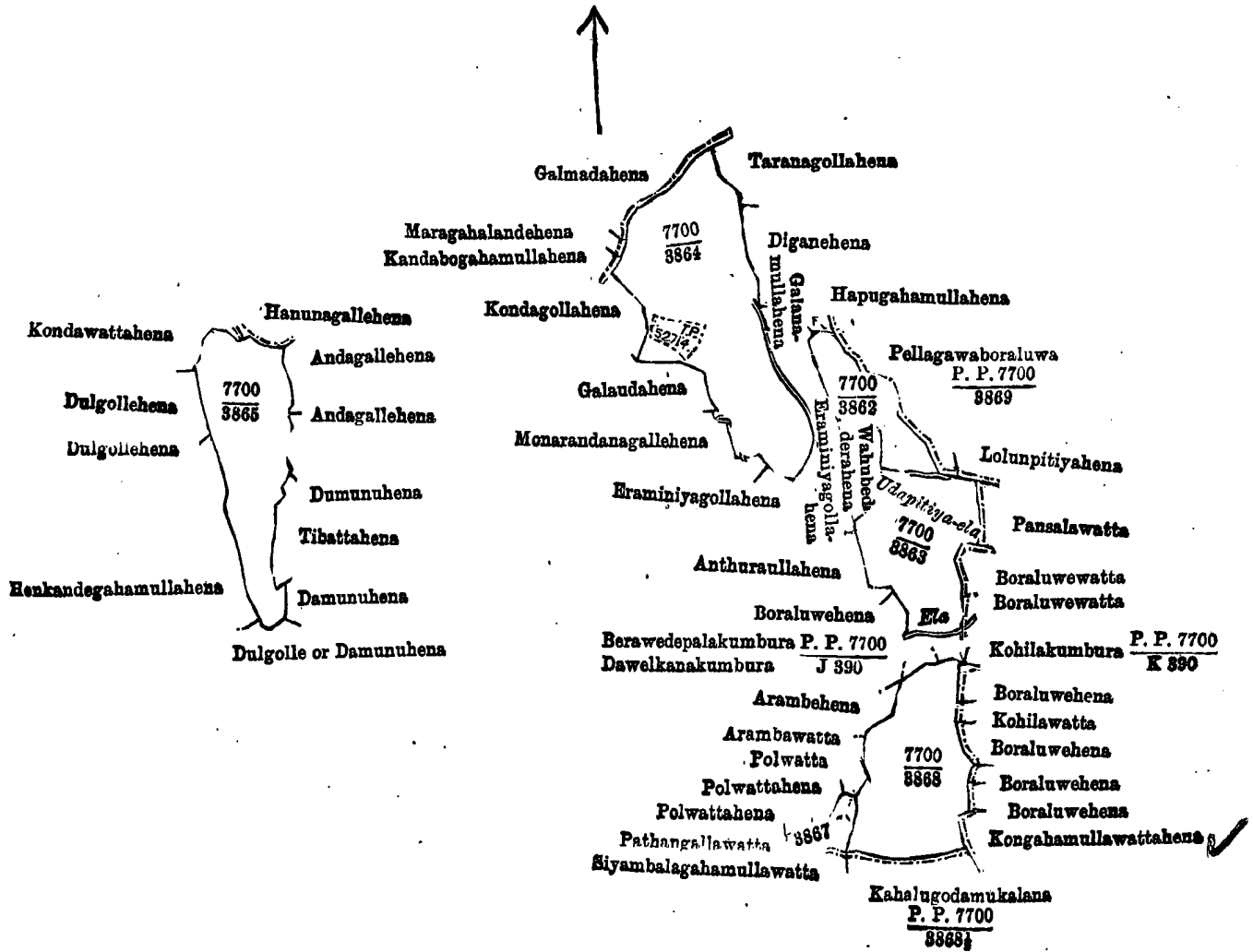
