NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 9th day of February, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein:

Description of Land referred to.

A block of land comprising lots 35 and 36 on preliminary plan 483 called Kalugalkonamukalana, situated in the villages Mahena and Mangedara in Otara pattu of Beligal korale, in the Kegalla District, containing in extent 31 acres 1 rood and 32 perches, as described in the annexed plan; bounded on the north by Kalugalkona-ela and Kiriwanahena; on the east by Galenda, Liniyagollchena, Kahatagahamullewatta, a rock, Deniyapahalahena, Lindamulakumbura, and the village boundary of Mangedara village; on the south by Uralindawatta (chena), part of village boundary of Tolangomuwa village, and Meragalayayehena; on the west by Meragalayayehena, a rock, Nugamullehena, a rock, Galenda, Galapallehena, a rock, Kalugalkonehena, Kurukeppetiyawehena, Kurukeppetiyawewatta ($\frac{483}{33}$), Kurukeppetiyawewatta ($\frac{483}{31}$), village boundary of Ambepussa village, and a path reservation.


