NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 9th day of February, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at my office at Matara and make claim to the said lands or any of them or to some interest therein :

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

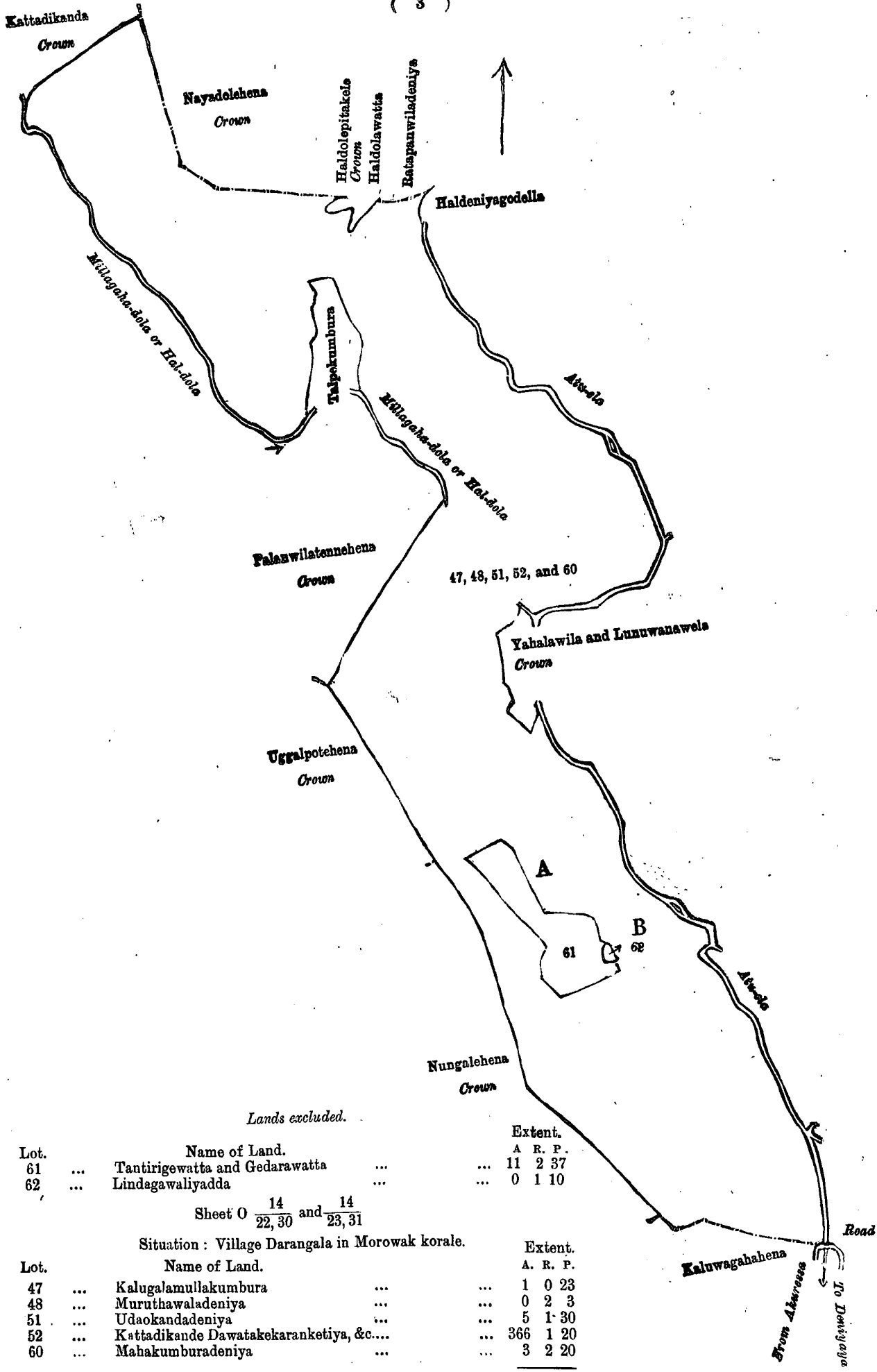
Description of Lands referred to.

The lands commonly called or known as Kattadikanda, Panganwalahena, Amittitennehena, Diganwilahena, Welipotawilahena, Yahalawilahena, Galpotawilahena, Modarawilahena, Kalugawila alias Kalugalamullekumbura, Murutawaladeniya, Udaokandedeniya, Mahakumburadeniya, all lying adjacent to each other and forming one block, situate in the village of Derangala in the Matara-Morowak, korale in the Southern Province, containing in extent 377 acres and 16 perches, as described in the annexed plan, shown as lots 47, 48, 51, 52, and 60 in Sheet O 14/22,30 and 14/23,31, and bounded as follows :

on the north by Kattadikanda belonging to Crown, Nayadolahena belonging to Crown, Haldolapitakella (lot 49) belonging to Crown, Haldolawatta claimed by Don Bastian Rubasinha, Ratapanwiladeniya claimed by Rubasinhage Don Hendrick; on the east by Haldeniya godella claimed by Don Bastian Rubasinha, the Atu-ela, and Yahalawila and Lunuwawela, Crown ; on the south by the road from Akuressa to Deniyaya, Kaluwagahahena claimed by Rubasinliyanage Bastian and others ; on the west by Nungalahena belonging to Crown, Uggalpotehena belonging to Crown, Palanwilatennahena belonging to Crown, the Millagahadola or Haldola, Talpekumbura (lot 45) belonging to Rubasinge Don Hendrick and others, the Millagahadola.

[NOTE.—Within these boundaries, (1) lot 61 Tantirigewatta and Gedarawatta, in extent 11 acres 2 roods and 37 perches, belonging to Liyanage Wattuhami and others, marked A in the annexed plan ; and (2) lot 62 Lindogawaliyadda, in extent 1 rood and 10 perches, belonging to Liyanage Wattuhami and others, marked B in the annexed plan, are excluded from this notice, and their aggregate acreage, viz., 12 acres and 7 perches, is not included in the acreage of 377 acres and 16 perches given above.]
