NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 19th day of March, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The following lots, all situated in the village Alawela in Kandupita pattu of Beligal korale, in the Kegalla District, as described in the annexed plan :-

1. Lots 4,375 and 4,381 on preliminary plan 189 called Horouwawaleymukalana and Borellakandehena, aggregating in extent 59 acres and 13 perches ; and bounded on the north by Werellehena (P. P. 302 / 8,026), a stream, Horouwawaley-ela, and the village boundary of Holombuwa village ; on the east by a stream, Niangaleyhena (P. P. 189 / 4,376), Idikadagahamulahena, Hapugahamulahena, Muruthagahamulleykumbura, Ratmaldehiyakumbura, a stream, and Utuwenakumbura ; on the south by Borellakandehena ; on the west by the village boundary of Holombuwa village, temple land described on title plan 65,506, Piladeniya Panwattehena (P. P. 302 / 8,029), Amugahamulahena (P. P. 302 / 8,028), and Horuwawaleymukalana (P. P. 302 / 8,025) separately surveyed.

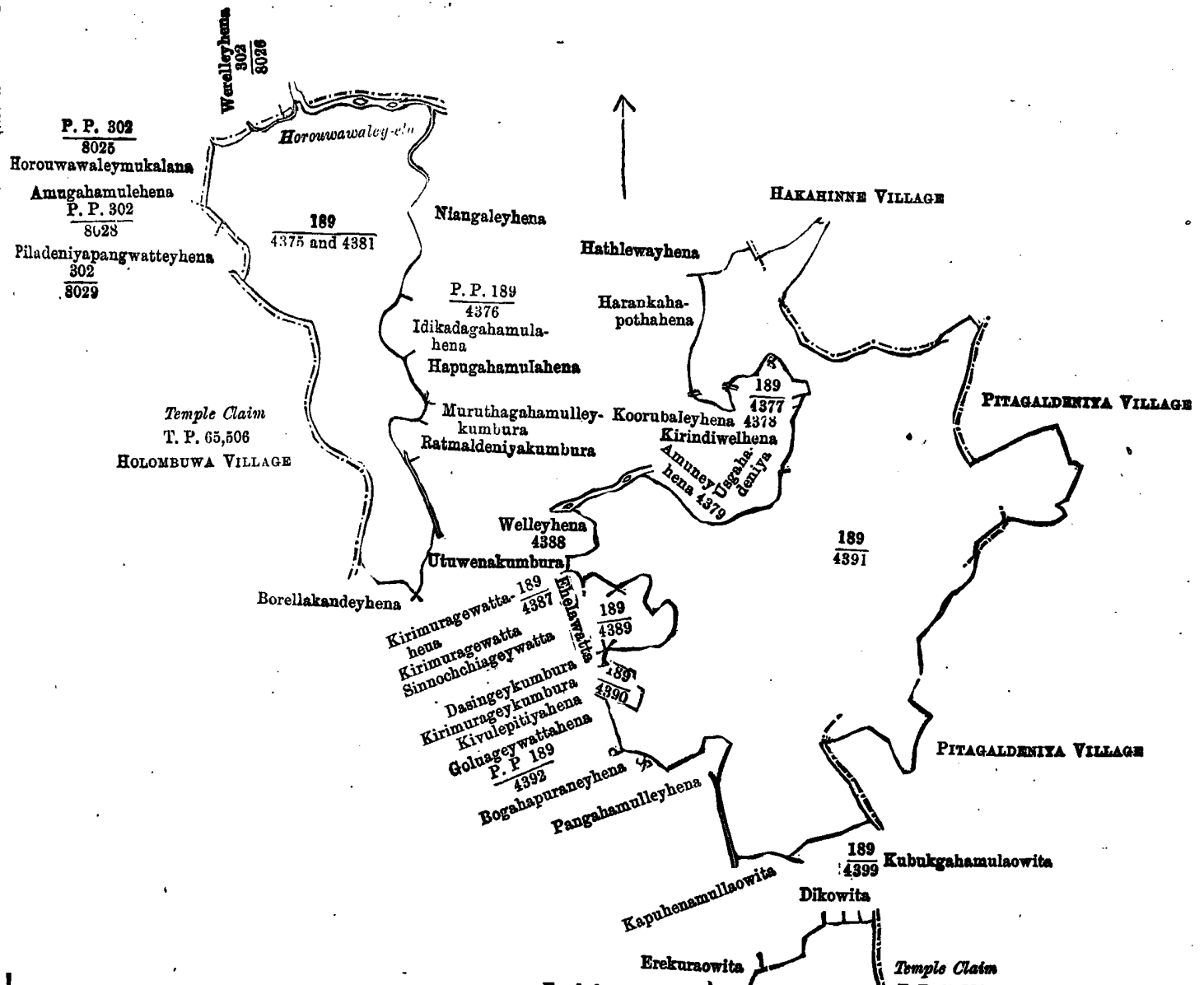
2. Lot 4,391 on preliminary plan 189 called Tharanagaleymukalana, in extent 149 acres 1 rood and 20 perches ; and bounded on the north by Hathlewayhena and the village boundary of Hakahinna village ; on the east by the village boundary of Pitagaladeniya village ; on the south by Kumbukgahamulaowita (P. P. 189 / 4,399) and Kapuhenamulleowita ; on the west by a stream, Pangahamulleyhena, Bogahapuranehena, Goluageywattehena (P. P. 189 / 4,392), Kivulepitiyahena (P. P. 189 / 4,390), Kirimurageykumbura, Dasingeykumbura, Ehelawatta (P. P. 189 / 4,389), Sinnochchiageywatta, Kirimurageywatta, Kirimuragey-wattehena (P. P. 189 / 4,387), Welleyhena (P. P. 189 / 4,388), a stream, Amuneyhena (P. P. 189 / 4,379), Usgahadeniya, Kirindiwelhena, Kooru-balayhena (P. P. 189 / 4,378), Usgahadeniya-aswedduma (lot 4,377 on preliminary plan 189), and Harankahapothahena.

3. Lots 4,400 and 4,401 on preliminary plan 189 called Makulgastenneowita and Egodadeniyahenyaya, aggregating in extent 48 acres and 10 perches ; and bounded on the north by Dikowita ; on the east by temple land described in title plan 65,784 and the village boundary of Pitagaladeniya village ; on the south by the village boundary of Pitagaladeniya village and a portion of Hallawahenamukalana (P. P. 189 / 4,412) ; on the west by Hallawahenamukalana (P. P. 189 / 4,412), Egodadeniyapurana (P. P. 189 / 4,405), Egodadeniyakumbura (lot 4,403 on preliminary plan 189), Egodadeniya-aswedduma (lot 4,406 on preliminary plan 189), Egodadeniyapurana (P. P. 189 / 4,402), Egodadeniyakumbura (P. P. 189 / 4,404), Egodadeniyaowita, and Erekurowita.
