NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 16th day of March, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at my office at Matara and make claim to the said lands or any one or to some interest therein:

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The lands commonly called or known as Jambughahena, Kaluwagahahena, Potuwilahena, Ellehena, Rilatennehena, Kudagalahena, Kandehena, Bowitiyaketiyahena, Ulgalalangahena, Mahapatana, Millagahatennehena, Elaihalahena, Panganwelehena, Tennehena, Madutapurehena, Patagurudolahena, Waljambughahahena, Migahawattahena, Nanawalahena, Migahawattahena, Patagurudeniyehehena, Galpottchena, Halwinnehena, Koskebellahena, Kadallehena, Radadolahena, Wagachohikandehena, Kandedolahena, Potuwilatennehena, Nattewilahena, Banwalahena, Galpotahena, Mahapotta, all lying adjacent to each other and forming one block, situate in the village of Gorakawala in the Matara-Morowak korale, in the Southern Province, containing in extent 2,057 acres and 20 perches, as described in the annexed plan, shown as lots 4 1/2, 5 1/2, 7, 8, 9, 11, 12, 13, 14, 15, 16, 20, 23, 24, 25, 28, 29, 30, 31, 32, 33, 38, 41, 1 1/2, 2, and 42 in sheets O 14/55, 14/63, 14/39, 14/47, 14/38, 14/46, 14/23, 14/31, 14/54, 14/62, 14/37, 14/45, and 14/22, 30, and bounded as follows: on the north by Kalugalawilahena belonging to Crown, Diyaporaketiya-henadeniya claimed by Derangola Liyanage Wattuhami, Kandahena, &c. belonging to Crown, Kandadola, Nungalladola, Nungallahena belonging to Crown, Kattadikanda, &c., claimed by Derangola Liyanage Wattuhami; on the east by the high road from Akuressa to Morowaka, Galpottchena sold by Crown to Thoma Hami (title plans 91,991, 91,989, and 91,988), Kudagalahena sold by Crown to Dahanayaka of Godapitiya (title plan 91,985); on the south by Kudapotta sold by Crown to Mr. C. LeMesurier (title plan 160,139), Mahapotta sold by Crown to Edirisinghage Don Bastian (title plan 174,215), Murukandola, Nattewilahena sold by Crown to Mr. C. LeMesurier (title plan 158,959), Nattewilahena claimed by Mr. C. Le Mesurier, Nattewiladola or Murukandola, Masdeniya sold by Crown to H. L. Denoris (title plan 166,732), the footpath from Gorakawala to Tennehena, Galpottchena belonging to Crown, Halinahena, &c., belonging to Crown, the Halinadola, the Galpottedola; on the west by the Hulandawa-ganga, Benwalahena belonging to Crown, the Gurubiledola, the Gurubileehena, &c., belonging to Crown, a water-course, the Galpottedola, Gurubilehena, &c., belonging to Crown, the Jambughahenadola.

[NOTE.—The following lots, lying within the above-named boundaries, are excluded from this notice, and their aggregate acreage, viz., 30 acres 1 rood and 2 perches, is not included in the acreage of 2,057 acres and 20 perches above-named.

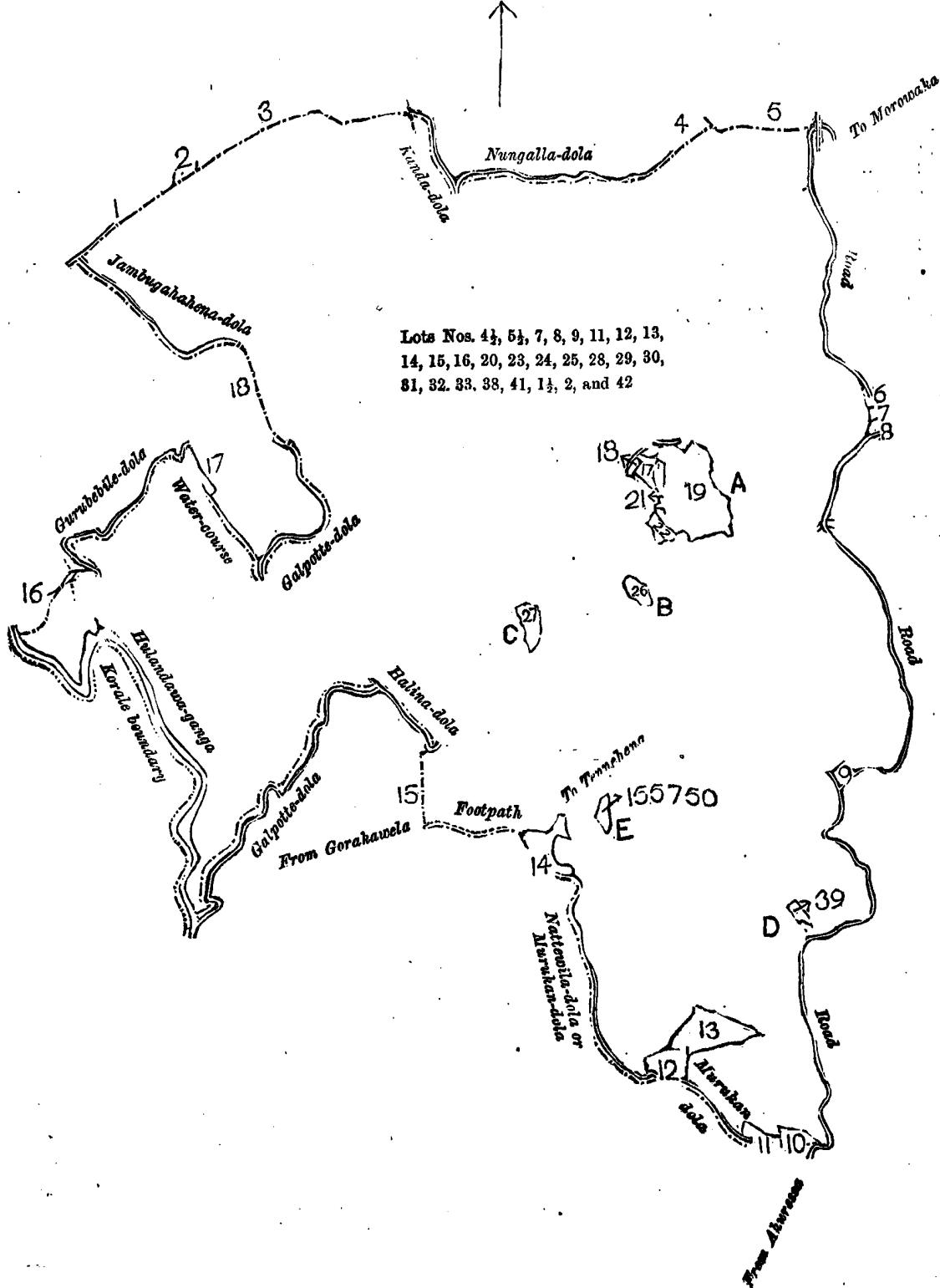
