NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 9th day of February, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein :

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The following lots, all situated in the village Uwana in Kanduaha pattu of Paranakuru korale, in the Kegalla District, as described in the annexed plan, lots O 68, O 68 1/2, 1,428, 1,429, 1,429 1/2, and 1,480 on preliminary plan 539, called Siyambalawahenyaya, Kandahenamukulana, and Kandahenamukalanadeniya respectively, aggregating in extent 149 acres 2 roods and 31 perches ; and bounded on the north by Dandenyahenyaya claimed by Gamage Kirihami Vedarala and others, Kirigala or Mahalianhenamukulana P. P. 539 1,401 claimed by the Crown, and the village boundary of the Eregama village ; on the east by Kotapillemulakana P. P. 539 1,406 claimed by the Crown, Udawatta claimed by Ranhami, Hapugahamulahenawatta claimed by Ranhami, Hinahenyaya claimed by Punchirala Mohotala and others, Hinahenamukulana P. P. 539 1,412 claimed by the Crown, Walapitiyahenyaya claimed by V. Achillage Appu and others, and the village boundary of Parambe village ; on the south by Wadanapahayayahenyaya P. P. 539 1,418 claimed by the Crown, a Mala-ela, and Gonnagalamukulana P. P. 939 1,425 claimed by the Crown, and the village boundary of Kurumbapitiya village ; on the west by Paladeniyawatta claimed by R. Dingira, Ihala-paldeniya claimed by K. Dingiri, Nagahamulakumbura claimed by H. Punchimenika, Pillewa claimed by Punchi Banda, a path, a stream, Garindakumbura claimed by H. Dingiri Banda, a path, Kirindagewatta claimed by Radage Kirimuta, Siyambalakumbura claimed by Ranhami and others, Siyambalawatta and Walawwewatta claimed by K. Tikiri Banda, Pitigahamulhenawatta claimed by Ihawalawwe Dingiri Banda and others, Panwatta and Walawwewatta claimed by Tikiri Banda, Madakumbura claimed by M. Punchirala and others, a path, and the village boundary of Eregama village. Lots P 68, P 68 1/2, Q 68, and 1,431 on preliminary plan 539, called Kiridenalanda and Kirdendenalandamukulana respectively, aggregating in extent 23 acres and 29 perches ; and bounded on the north by Tnbodalanbenyaya claimed by Gamage Kirihami Vedarala and others and the village boundary of Eregama village ; on the east by Udamurekumbura claimed by H. Dingiri Banda and others, Varakakumbura claimed by P. Tikiri Banda and others, Arakbodakumbura and Yatiyanwelakumbura claimed by J. Dingiri Appu, Dewatakumbura claimed by A. Mudalihami, Urukotukumbura claimed by the vuhare, Paldeniyaawatta claimed by R. Dingira ; on the south by lot 230 on preliminary plan 142 and the village boundary of Kurumbapitiya village ; on the west by Pannalawatta claimed by A. Uranihami, Pannalakumbura claimed by Mudalihami and others, Batupitiyakumbura claimed by R. Jelis Appu and others, and Yakdehigewatta claimed by Punchi Banda, and the village boundary of Eregama village.


