## Award

An industrial dispute between the parties above named was referred to this Tribunal by the Hon'ble Minister of Labour and Employment under Section 4 (1) of the Industrial Disputes Act, Chapter 131, of the Legislative Enactments of Ceylon as subsequently amended, for settlement by arbitration by his Order dated 5th September, 1969. In the statement of the Commissioner of Labour, which accompanied the Minister's Order, the matter in dispute was stated to be whether the non-employment of N. Muthusamy as Kangany by the management of Oakwell Group, Haldummulla, is justified and to what relief he is entitled relief he is entitled.

- (1) The applicant Union gives up its claim for reinstatement in respect of the workman and the management agrees to retire the workman on the estate. The management agrees to pay the workman a sum of Rs. 200 ex gratia in full and final settlement of all his claims, inclusive of statutory claims, of any.
- (2) The management agrees to deposit the above sum of Rs. 200 (Rupees Two Hundred) with the Labour Officer, Haputale, on or before 15th January, 1970 for payment to the workman.
