NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 9th day of February, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachoheri and make claim to the said land or to some interest therein.

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

A block of land comprising lots 27 and 28 on preliminary plan 483 called Welikandamukalana, situated in the villages Hunuwala, Mangédara, and Talawatta in Otara pattu of Beligal korale, in the Kegalla District, containing in extent 38 acres 3 roods and 20 perches, as described in the annexed plan; and bounded on the north by Paspolakanda and Batahenamukalana ($\frac{1483}{2}$) ; on the east by Jambugahamulahena, Nagahamulahena, Guruhellehena, Tennahena, Nugamulahena, and Bakmigollehena ; on the west Dulmerahena, Varalugalahena, Kudalugahahena, Andahena, Gurudeniyahena, Hapugahamulahena, village boundary of Hunuwala village, Mala-ela, Kiriwanahena, Aswedumekumbura, and Etikehelgahamulahena and on the south by Outtuhena.


