NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 2nd day of March, 1900, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before me at the Kegalla Kachcheri and make claim to the said land or to some interest therein.

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said land, to which no claim has been made, is the property of the Crown.

Description of Land referred to.

A block of land comprising lots 1,930 and 1,931 on preliminary plan 7,130 and 4,551 on preliminary plan 7,792 called Pansalawatthana, Ganegalamukalana or Mukalanahena, and Gonagalamukalana respectively, situated in the village Kadigamuwa in Kandupita patty of Beligal korale, in the Kegalla District, in extent 58 acres and 1 rood, as described in the annexed plan; and bounded on the north by Ambatenahena and Baladahena; on the east by Radawgehena, Kurukosgahamulahena, Appugehena, Pillagawahena, Kehelwela-ela; on the south by Barawadeniyawela, village boundary of Bambaragama village, Mahaowitahena; on the west by Ganegalamukalana (preliminary plan 7,830), land described on title plan 4,287.


