## **NOTICES UNDER THE WASTE LANDS ORDINANCES.**

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

**T**AKE notice, that unless within three months from the 19th day of March, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at the Kegalla Kachcheri and make claim to the said lands or any of them or to some interest therein.

I, Bertram Hill, Assistant Government Agent for the District of Kegalla, in the Province of Sabaragamuwa, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

*Description of Lands referred to.*

The following lots, all situated in the village Tiyambarahena in Kanduaha pattu of Paranakuru korale, in the Kegalla District, as described in the annexed plan:—

1. Lots 1344, 1345, and E 66 no preliminary plan 519 called Minimaruukalana and Yatapanamukalana, and lot 6,563 on preliminary plan 8,521 called Yatapana, aggregating in extent 18 acres 1 rood and 34 perches; and bounded on the north by Gurugoda-oya; on the east by Atoluhen, Atoluwa, a reservation, Uda-ambagahahena, Dampitiyahena; on the south by Dampitiyawatta, Dewalewattahena, and Dewalewattahena reservation; on the west by Gurugoda-oya, Ilagotupolahena, Nagotunolahena, reservation, reservation on Gurugoda-oya, and Gurugoda-oya.

2. Lots 1346 and 1347 on preliminary plan 519 called Minimaramukalana and Yatapanamukalana, in extent 1 acre 1 rood and 5 perches; and bounded on the north by Dewalewattahena and Dewalewattahena reservation; on the east by Dewalewattahena; on the south by Kahatatennehena, Galakotuwewena, and Hara-attehena, and reservation on the Gurugoda-oya, consisting of portions of the above chenas, Kahatatennehena, &c.; on the west by Gurugoda-oya.


