NOTICES UNDER THE WASTE LANDS ORDINANCES.

[Notice under Ordinances No. 1 of 1897 and No. 1 of 1899.]

TAKE notice, that unless within three months from the 16th day of March, 1900, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before me at my office at Matara and make claim to the said lands or any one or to some interest therein :

I, John Penry Lewis, Special Officer appointed under Ordinance No. 1 of 1897, in pursuance of the powers in me vested by Ordinances No. 1 of 1897 and No. 1 of 1899, shall declare by writing under my hand that the said lands or such of them, to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The lands commonly called or known as Jambughahena, Kaluwagahahena, Potuwilahena, Ellehena, Rilatennehena, Kudagalahena, Kandehena, Bowitiyaketiyahena, Ulgalalangahena, Mahapatana, Millagahatennehena, Elaihalahena, Panganwelehena, Tennehena, Madutapurehena, Patagurudolahena, Waljambughahena, Migahawattahena, Nanawalahena, Migahawattahena, Patagurudeniyehehena, Galpottahena, Halwinnehena, Koskebellahena, Kadalallehena, Radadolahena, Wagachchikandehena, Kandedolahena, Potuwilatennehena, Nattewilahena, Banwalahena, Galpotahena, Mahapotta, all lying adjacent to each other and forming one block, situate in the village of Gorakawala in the Matara-Morowak korale, in the Southern Province, containing in extent 2,057 acres and 20 perches, as described in the annexed plan, shown as lots 4 1/2, 5 1/2, 7, 8, 9, 11, 12, 13, 14, 15, 16, 20, 23, 24, 25, 28, 29, 30, 31, 32, 33, 38, 41, 1 1/2, 2, and 42 in sheets O 14, 14, 14, 14, 55, 63, 39, 47, 38, 46, 23, 31, 14, 14, 14, 14, 54, 62, 37, 45, and 22, 30, and bounded as follows : on the north by Kalugalawilahena belonging to Crown, Diyaporaketiya-

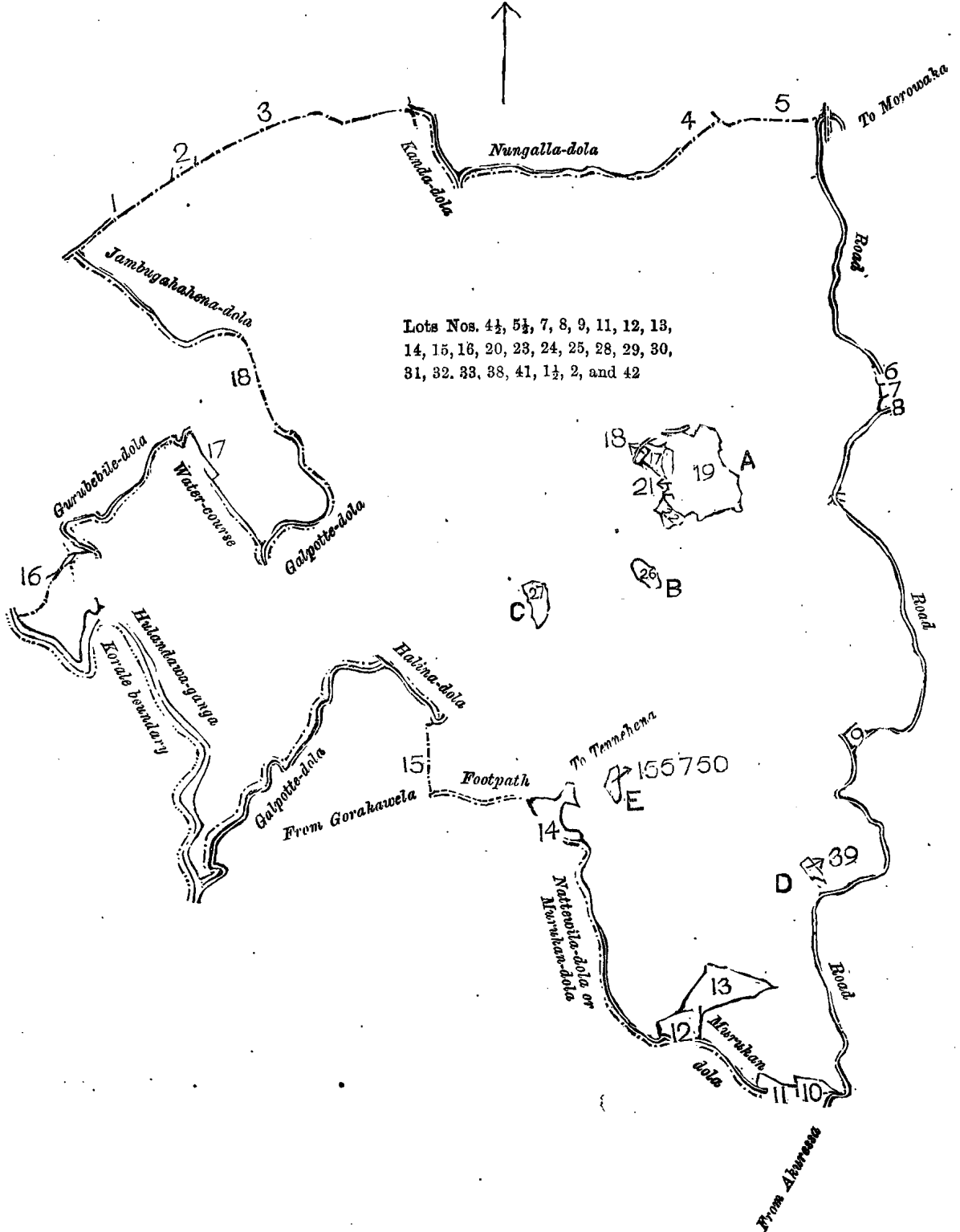
