Award

This is an award made under section 17 of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon (1956 Revised Edition), as amended by the Industrial Disputes (Amendment) Acts, Nos. 14 and 62 of 1957, 4 of 1962 and 39 of 1968 (read with the Industrial Disputes (Special Provisions) Act, No. 37 of 1968).

The above-named parties to the dispute having consented to seek settlement by arbitration and having nominated me as arbitrator for the said purpose, the Commissioner of Labour, by Order made under section 3 (1) (d) of the aforesaid Act, on the 18th December, 1969, referred the dispute to me for settlement by arbitration. The matter in dispute is "whether the basis on which the production of light foil is included for the calculation of Production are presently said by the Company. calculation of Production Bonus, presently paid by the Company, is fair and equitable, and if not, in what manner should it be varied ".

Mr. M. C. M. Shaffie for the United Engineering Workers' Union (hereinafter referred to as "the Union"), and Mr. Lynn Wirssekera for the Acme Aluminium Company Ltd. (hereinafter referred to as "the Company"), appeared before me on the 13th January, 1970, at the Industrial Courts, Colombo. After their addresses it was agreed that the court should visit the works; and we therefore inspected the production processes at the Company's premises on the 20th January, 1970, before reviewing the evidence at the Industrial Courts later. Court sat again on the 25th February, 1970, when, after some further discussions and submissions, the case was concluded.

Any bonus or incentive scheme can be successful only if there Any bonus or incentive scheme can be successful only if there is the utmost co-operation and understanding between the management and the operators. This had been achieved in the case of the production of medium foil. Extra machinery was introduced and additional operators were employed to process a part of the medium foil into lighter foil without this full co-operation and understanding between the two parties.

This new and extra process does not involve any difference in skill, responsibility, effort and working conditions as far as the operators are concerned. Much of the work is machine controlled and performed at predetermined speeds not fully within the control of the operator. There are also periods of relaxation during the machine cycle. The processes are, no doubt, apparently different, but from a job evaluation and merit-rating basis, I do not consider them to be different. The fact that the same operators are able to work on both sets of processes satisfactorily, whenever necessary due to absence or otherwise, confirms my view.

The bonus is paid as a percentage of the gross earnings, excluding overtime. I am satisfied that the basis of apportioning the total output in the proportion of normal man-hours to normal and overtime man-hours is fair and equitable.

There has been insufficient communication in both directions. The measurement of the output earning the bonus is not very simple, and the difficulty of the operators to understand this fully is partly responsible for the lack of understanding between the parties. Prompt and fair compensation had been paid for delays beyond the control of the operators, though the agreement was to pay no compensation for delays beyond the control of the management. Light foil imported direct, but processed further, is also counted for bonus calculations.

The bonus or incentive system is at straight piece rates above an agreed minimum production and is also a group bonus scheme. The dispute is really about the fairness and accuracy of the measurement of the peice-work in the production of the light foil and as compared with that of the medium foil.

Mr. Lynn Wirasekera maintains that the measurement of the light foil has to be on the same basis of weight for weight as for medium foil. The production of light foil, however, involves more processes and more wastage. The Company has, no doubt, softened this by not increasing the minimum output required for bonus calculation—in spite of the fact that they had incurred additional expenditure on both capital and labour. However, the measurement of piece-work for medium foil was agreed to be on areas and not on weights. For light foil production, however, I do not consider that the measurement of work by equivalent weights to be satisfactory without the application of a co-efficient for waste. The parties agreed to the payment of bonus for over 250,000 sq. feet of production. The Company is able to salvage part of the wastage at every extra passing or processing, but the operator loses the whole of the wasted area in the calculation of the bonus.

After giving due consideration to the above and all other matters placed before me, I conclude that the equivalent weight of light foil produced has to be increased by twenty per cent. before conversion into areas for the calculation of bonus to be fair and equitable, and I award accordingly.

THE INDUSTRIAL DISPUTES ACT, CHAPTER 131

THE Award transmitted to me by the Arbitrator to whom the industrial dispute which had arisen between the Ceylon Estates Staffs' Union, 13, Kande Vidiya, Kandy, and Eastern Produce and Estates Company Limited, the Proprietors of Vellai Oya Estate, Hatton (C/o. Harrisons & Crosfield Ltd., Prince Building, 14, Prince Street, Fort, Colombo), was referred by Order dated October 30, 1968, made under section 4 (1) of the Industrial Disputes Act. Chapter 131, as amended, and published in Ceylon Government Gazette No. 14,827 of November 8, 1968, for settlement by arbitration is hereby published in terms of section 18 (1) of the said Act.

Award

By Order dated 15th October, 1968, made by the Honourable Minister of Labour, Employment and Housing, in terms of section 4 (1) of the Industrial Disputes Act, Chapter 131 of the Legislative Enactments of Ceylon (1956 Revised Edition), as amended by Acts Nos. 14 and 62 of 1957 and 4 of 1962, an industrial dispute between the aforesaid parties in respect of the matters hereinafter specified has been referred to me for

settlement by arbitration. The Commissioner of Labour has, in his statement dated 25th October. 1968, issued in terms of section 16 of the aforesaid Act set out the matters in dispute between the parties as follows:—

- "Whether the termination of employment of Mr. P. C. J. Velu, Head Clerk, on Vellai Oya Estate, Hatton, by the Management of the said Vellai Oya Estate is justified and to what relief he is entitled."
- 2. In the statement dated 18.11.68 of the Ceylon Estate Staffs' Union (hereinafter referred to as 'the Union') filed on behalf of its member Mr. P. C. J. Velu, it was averred, inter alia—
 - (a) that on an alleged incident purported to have taken place on 13th August, 1968, the Superintendent of Vellai Oya Estate (a property of the Eastern Produce and Estates Co. Ltd.), suspended the services of its member Mr. P. C. J. Velu, on 17.8.68 and summarily terminated his services on 3.9.68;
 - (b) that the termination of the services of Mr. Velu was an act of victimization, and in any event completely unjustified,

and it prayed that Mr. Velu be reinstated in his post with retrospective effect, and that he be paid back wages for the period of his remaining unemployed.

- 3. The Eastern Produce and Estates Co. Ltd., Proprietors of Vellai Oya Estate, Hatton (hereinafter referred to as 'the Management') set out its case in its statements dated 25.11.68 and 22.12.68 as follows:—
 - (a) That on or about the 13th August, 1968, the said Mr. P. C. J. Velu was guilty of gross insubordination and/or misconduct unbecoming of an employee holding a position of confidence and trust, in that he did during working hours and in the presence of the office staff refer to Mr. S. B. Pilapitiya, the Superintendent of Vellai Oya Estate, in most disparaging, derogatory and abusive terms.
 - (b) That after an inquiry Mr. Velu's services were terminated with effect from 3rd September, 1968, and that his termination was lawful and justified, and that his conduct in question or his past record did not entitle him to any relief in law or equity.
 - (c) That the Management denied the allegation that the termination of Mr. Velu's services was an act of victimization or was unjustified.
- 4. At the inquiry held to determine this matter Mr. V. Karalasingham, instructed by Mr. Marshall Perera, appeared on behalf of the Union, while Mr. R. A. Kannangara, instructed by Messrs. Julius & Creasy, appeared for the Management.
- 5. The suspension and termination of the services of Mr. Velu was the direct result of an incident that occurred at 7.30 a.m. on 13th August, 1968, after the normal office routine commenced.
- 6. Mr. S. K. S. Perera, a Stenographer, in the employ of the Management, stated in his evidence that while checking the letters Mr. Velu made the following remarks which the Management submits are a reference to Mr. Pilapitiya in disparaging, derogatory and abusive terms:—
 - "Yesterday was Labour Day. You were out, and Ponnambalam was out. There was no one to type a letter. I did not have any letter heads. Mr. Pilapitiya is trying to teach me a lesson. Before that I will teach him a lesson. I will drag him to courts. Then only he will learn who Velu is. I am prepared to face anything. I am worse than a Sinhalese. From a letter-head to a pencil I have to go and ask him. For a drop of ink I have to go and suck his bloody arse. What is the use of my being a Head Clerk when I cannot get a letter-head whenever I want. He may be a bloody Superintendent; I don't care. I do not know from where he learnt the Superintendent's work. There were better Superintendents on this estate but no one did like this. He is keeping a private clerk. I don't care whether he kept 10 private clerks even. But why does the estate pay for that? This is not his bloody granny's arse. This is the Eastern Produce Company. Why should the estate pay for his private clerk who types his visiting reports? He thinks I am a bloody fool. I will make him to know who the bloody fool is. I am the Head Clerk here. I want my Assistants to work full 8 hours' work. Yesterday I thought of giving him tight, but I am patient because I am the father of many children. Next day I won't keep quiet. I will dash everything to his bloody face and go."

Further Mr. Perera said that Mr. Velu abused Mr. Pilapitiya in filthy and obscene language in Sinhala, making reference to Mr. Pilapitiya's mother.

- 7. The other witness called by the Management was the Senior Assistant Clerk, Mr. C. Ponnambalam, who repeated practically the same remarks attributed to Mr. Velu.
- 8. To meet these allegations the Union called Mr. Velu, the Head Clerk, against whom all these allegations had been made. According to Mr. Velu, a strike called the 'maha Uva' strike

of all the employees in the up-country estates, in sympathy with which the Ceylon Estate Staffs' Union also participated, ended on or about 12th July, 1968. Immediately after this the administration of the office was re-organized. Circular marked R7 and A3 dated 12th July, 1968, was issued by the Superintendent of Vellai Oya Estate which stated:

"Other than the official typist no other member of the office staff is to enter the typist's room. If any forms etc. are required from this room arrangements will have to be made with the Head Clerk to obtain the necessary forms."

The keys of the office room, the typist's room and other keys were removed from the custody of the Head Clerk by Mr. Pilapitiya, the Superintendent.

- 9. Consequent on this step being taken Mr. S. K. S. Perera, the Stenographer, was responsible for the distribution of stationery—which, in the opnion of Mr. Velu, undermined his influence as Head Clerk in the eyes of his subordinates.
- 10. On discovering the lapse on the part of Mr. Perera in incorrectly typing R3. Mr. Velu admitted that, while finding fault with him, he made the following general remarks:—
 - "Everything is under lock and key. No Head Clerk will tolerate this type of difficulty. By informing the Union I will see an end to this very soon. I never tried to tell my subordinates that I have a longer service than the Manager."
- Mr. Velu admitted that he said in Sinhalese that whoever causes these difficulties to him will be struck by lightning. Mr. Velu denied that the general remarks that he made were intended for Mr. Pilapitiya in particular.
- 11. This incident resulted in an inquiry held by the Personnel Officer on 17.8.68, on which date the services of Mr. Velu were suspended with immediate effect by letter marked A4 of the same date. Mr. Velu, in reply, by letter marked A5 dated 19.8.68, stated that there was no inquiry as such on 17.8.68, that he refuted the allegations and that he offered an explanation for the unfounded allegations made by Mr. S. K. S. Perera and Mr. C. Ponnambalam both of whom had been taken to task by him regarding lapses in their work. He further requested the Superintendent to furnish him with the charges against him and copies of complaints made against him, if any. The Superintendent replied by letter marked A6 of 20.8.68 stating that the 'resumed domestic inquiry' will now be held on 24.8.68, and that the charges will be communicated once a prima facie case has been established.
- 12. It is inexplicable how, without further inquiry to determine whether there was a prima facie case, a charge sheet marked A7 dated 26.8.68 was served on Mr. Velu. However, to this charge sheet Mr. Velu in his letter marked A8 dated 1.9.68 replied as follows:—
 - "(a) I deny having used any disparaging, derogatory or abusive terms referring to you. Such allegations are baseless and unfounded.
 - (b) A letter from the Deputy Food Controller. Kandy, asking for proof of residence of a labourer was on my desk for my attention.
- desk for my attention.

 (c) Without any authority, knowledge or instructions Mr. S. K. S. Perera removed this letter from my desk and attended to it in a wrongful manner, i.e. he had typed out a Memo to the Assistant Superintendent authorising the issue of Rations contrary to the requirements of the D.F.C. to furnish proof of residence. I viewed the whole matter seriously because had I sent the letter up to you for your signature by an oversight I would have laid myself open to a serious charge. Also the Management, which includes yourself, would have been taken to task by the D. F. C. for issuing rations without his authority. Therefore, in the best interests of the estate and as I was entitled to as Head of the Department, I took Mr. Perera to task for what he did. The Memo typed by Mr. Perera and the letter from the D.F.C., Kandy, are now in your custody. Does this reflect misconduct on my part?

I regret very much that an unfounded charge based on HEARSAY should be made against me in spite of my loyal service to you.

In conclusion I submit that you have no cause whatsoever to terminate my service and would request you to rescind the suspension order on me and allow me to resume duties.

- 13. In spite of this explanation offered by Mr. Velu, the Superintendent. without further inquiry, terminated his services by letter marked A9 dated 3.9.68.
- 14. In assessing, the evidence of Messrs. Ponnambalam and Perera one cannot fail to consider the following circumstances:—
 - (a) The reorganization of the administration of the office deprived Mr. Velu of the office keys and his independence.
 - The distribution of stationery which was formerly in the hands of the Head Clerk was assigned to Mr. S. K. S. Perera, the Stenographer.

- The difficulties resulting from the reorganization were brought to the notice of the Management by Mr. Velu immediately an opportunity afforded itself.
- The reorganization unfortunately coincides with Mr. Velu's elevation to the position of President in the local Branch of the Ceylon Estate Staffs' Union. On the other hand, Management's explanation is that the reorganization was necessary in view of the discovery of some confidential papers in the drawers of the subordinate staff during the period of the 'maha Uwa' strike. The Union therefore, alleges that the reorganization was an act of victimization.
- (b) Mr. C. Ponnambalam was a rival candidate to Mr. Velu for the post of Head Clerk, and the selection of Mr. Velu would undoubtedly have left some rancour in him.
 - According to R1, Mr. Ponnambalam had occasion to report Mr. Velu to the Superintendent for insulting him and calling him a 'a bloody idiot, a bastard and so many other things'. Mr. Velu admitted that he was warned for using these words against Mr. Ponnambalam; he, however, denied that he called him a bastard.
 - Mr. Ponnambalam himself admitted that he was taken to task by Mr. Velu for not keeping the Accounts correctly.
 - In these circumstances could one consider Mr. Ponnambalam to be an impartial and an unbiased witness on whose testimony one could act?
- (c) It transpired in evidence that Mr. S. K. S. Perera was appointed by Mr. Pilapitiya, the Superintendent, without regard to the normal procedure of advertising the vacancy, a procedure that is in vogue in estates. Mr. Perera had worked with Mr. Pilapitiya on one estate before he came to be employed on Vellai Oya Estate.
 - According to Mr. Velu's evidence, all confidential correspondence had been taken out of his hands and assigned to Mr. Perera.
 - It is admitted that Mr. Velu had found fault with Mr. Perera's work as well.
 - Mr. Perera's relationship with the Superintendent had placed him in an enviable position that irked the Head Clerk who was disgusted with the activities of Mr. Perera
 - In view of these circumstances Mr. S. K. S. Perera's evidence has to be viewed with caution.
- (d) The most important circumstance in this inquiry is the delay in reporting this incident that took place at about 7.30 a.m. on 13.8.68. Although Messrs. Ponnambalam and Perera had the opportunity of reporting this matter to Mr. Pilapitiya on that day itself when the Superintendent came to the office at 11 a.m., no attempt had been made to acquaint him of this alleged disparaging, derogatory and abusive language directed against him till 16.8.68.
 - That circumstance, to my mind casts much suspicion on the credibility of these two witnesses.
- (e) The allegations of insults and disparaging references to Mr. Pilapitiya had no relation to the incident that occurred on the 13th morning. Even on discovering the lapse on the part of Mr. Perera it is strange that no words had been directed against Mr. Perera himself for his fault. It is inconceivable that early that morning Mr. Veln should get into a fit of temper and deliver abuses at Mr. Pilapitiya when actually the culprit was Mr. Perera himself.
- (f) Mr. Pilavitiya himself admitted that his relationship with Mr. Velu was cordial and that this was the solitary instance when Mr. Velu lost his temper. His evidence on that point, in re-examination, is at page 482, and is as follows:—
 - "Q: And it is only on that solitary instance that you thought that Velu is a man of violent temper?
 - A: Yes. Since my coming to the estate that was the first of its kind which happened in the office.
 - Q: But normally you found him to be a man of mild temper?
 - A: He has been very cordial to me outwardly.
 - Q: Is there any reason why he should not be cordial to you?
 - A: I do not know his feelings inside but outwardly he was very cordial. I had made some changes in the office which possibly he did not like."
 - Mr. Pilapitiya had in the latter part of 1967 given to Mr. Velu a recommendation for a post in a larger estate called Mada Kumbura Estate.
 - Could one presume that such vulgar abuse would be hurled against Mr. Pilapitiya even if there were difficulties in the administration of his office work?

- (g) The right of a normal inquiry was denied to Mr. Velu. Mr. Pilapitiya had failed to take the normal steps he took when Mr. Ponnambalam complained against Mr. Velu in 1967; instead of holding an inquiry he called upon the Personnel Officer to hold an extempore inquiry without notice to Mr. Velu, and his services were suspended on 16th August, 1968, without giving him an opportunity to defend himself.
- (h) Mr. Pilapitiya himself admits that now he has discovered that there are two factions in the office, and he fears that in future the administration of the office will be hampered due to the existence of these two factions.
- (i) Due to the failure of the Management to call any other evidence, especially of Mr. Murugaiah and others in support of the evidence of Mr. Perera, a presumption arises that their evidence would be adverse if called.
- 15. Under these circumstances I cannot accept the evidence of Mr. C. Ponnambalam and Mr. S. K. S. Perera, unreservedly. There is no doubt that the incident did take place. The version of the incident seems to my mind to have been exaggerated to suit them. Angry words may have been used in giving vent to his feelings against Mr. Perera, and, indirectly, against the administration in general, under provocation.
- It has been held that angry words spoken under provocation or disrespectful expressions or actions apologized for will not be held sufficient to sanction a dissolution of the contract of service—1952, 2 LLJ, p. 36.
- I am inclined to accept the evidence of Mr. Ve'u that under provocation he had uttered certain general remarks which may have contained insinuations against the Superintendent. His effusion cannot be considered mala fide but rather made in the interests of the employer. But if it is conduct which is prejudicial or likely to be prejudicial to the interests or the reputation of the master the master will be justified in dismissing the employee—1866, 17 QBD, p. 536, at p. 542, Pearce vs. Ford.

In my view, if any words were uttered, they were uttered in the furtherance of the interests of the employer and for achieving a better administration of the work in the office.

- 16. A point has been made that his past conduct regarding an incident connected with one Vettivelu and his involvement in a Magistrate Court Case for theft should be considered as sufficient ground for termination of the services of Mr. Velu. I am of the opinion that the employer has condoned those alleged offences and, therefore, is estopped from taking advan.age of such conduct at this stage. Mr. Pilapitiya has even given a recommendation to Mr. Velu and has stated in evidence that this is the first incident which has been reported to him regarding Mr. Velu's violent temper.
- 17. On a consideration of all these circumstances I cannot accept the evidence of Mr. C. Ponnambalam and Mr. S. K. S. Perera. In the circumstances there is no proof that Mr. Velu used the words attributed to him.
- I hold that the Management has failed to prove misconduct on the part of Mr. P. C. J. Velu as to justify his dismissal. I, therefore hold that the termination of the services of Mr. P. C. J. Velu by the Management of Vellai Oya Estate is unjustified.
- I order that Mr. P. C. J. Velu be reinstated in the same post he held at the time of his termination, within a month of the publication of this Award, reinstatement to be effective from the date of termination, i.e. 3.9.1968. He will be entitled to all rights, privileges and benefits he would have enjoyed had his services not been terminated.

In view of the fact that Mr. Velu should have been more restrained and composed on discovery of the lapse on the part of the Stenographer, Mr. S. K. S. Perera, I Order that Mr. Velushould only be entitled to draw half backwages for the full period he has been unemployed.

I make Award accordingly.
